ORDINANCE 2021-04

AN ORDINANCE AMENDING TITLE 8, MOTOR VEHICLES AND TRAFFIC, CHAPTER 2, STOPPING, STANDING AND PARKING OF VEHICLES, OF THE CITY OF ISLE OF PALMS CODE OF ORDINANCES TO PROVIDE NEW BEACH PARKING REGULATIONS ALONG PALM BOULEVARD.

WHEREAS, the Isle of Palms Council is empowered with the authority to make amendments to the Isle of Palms Code, including amending Chapters, and now wishes to do so;

WHEREAS, the Isle of Palms Council believes it necessary to make amendments to the City's Managed Beach Parking Plan to address concerns over parking, beach access, and the safety of pedestrians and motorists while also clarifying enforcement measures to protect the public safety of the residents and visitors of its community;

WHEREAS, the Isle of Palms Council now desires to amend Chapter 2, Article A, Article B, and Article C, to ensure the aforementioned objective.

BE IT ORDAINED AND ENACTED BY THE MAYOR AND COUNCIL MEMBERS OF THE CITY OF ISLE OF PALMS, SOUTH CAROLINA, IN CITY COUNCIL ASSEMBLED THAT TITLE 8, CHAPTER 2 SHALL BE AMENDED AS FOLLOWS. ALL SECTIONS OF TITLE 8, CHAPTER 2 NOT REFERENCED REMAIN UNALTERED.:

SECTION 1. That Article A, "General Provisions," Section 8-2-2, "General Prohibitions,"

Paragraph (1) (t) is hereby amended to include and to state the following:

(t) A. Along the rights-of-way of Palm Boulevard between 21st Avenue and 40th Avenue in any of the following manners:

- a1. Within four feet (4') of the pavement, except as otherwise posted;
- <u>b2</u>. In any manner other than angled parking in the designated marked spaces on the land side of Palm Boulevard;
- e3. In any manner other than parallel parking in the direction of traffic on the ocean side of Palm Boulevard and;
- <u>44.</u> Double parking on the passenger side of any vehicle that is parallel parked along the right-of-way on the ocean side of Palm Boulevard.
- B. Along the rights-of-way of Palm Boulevard between 42nd and 53rd Avenue in any of the following manners:
- 1. Within four feet (4') of the pavement, except as otherwise posted;
- 2. In any manner other than parallel parking in the direction of traffic; and

3. Double parking on the passenger side of any vehicle that is paralleled parked along the right-of-way.

SECTION 2. That Article B, "Resident Parking Districts," Section 8-2-31, "Obedience to parking regulations," Paragraph (a) (16) is hereby amended to include and state the following:

<u>A. Along the rights-of-way of Palm Boulevard between 21st Avenue and 40th Avenue in any of the following manners:</u>

- 1.a. Within four feet (4') of the pavement, except as otherwise posted;
- <u>b2.</u> In any manner other than angled parking in the designated marked spaces on the land side of Palm Boulevard;
- e3. In any manner other than parallel parking in the direction of traffic on the ocean side of Palm Boulevard and;
- d4. Double parking on the passenger side of any vehicle that is parallel parked along the right-of-way on the ocean side of Palm Boulevard.
- B. ——Along the rights-of-way of Palm Boulevard between 42nd and 53rd Avenue in any of the following manners:
 - 1. Within four feet (4') of the pavement, except as otherwise posted;
 - 2. In any manner other than parallel parking in the direction of traffic; and
 - —Double parking on the passenger side of any vehicle that is paralleled parked along the right-of-way.

<u>SECTION 3. That Article C, "Beach Parking," Section 8-2-41, "Definitions" is hereby</u> <u>amended to include and state the following:</u>

<u>Angled parking shall mean parking of a vehicle in a delineated parking space aligned at an angle not exceeding sixty (60) degrees.</u>

SECTION <u>34</u>. That Article C, "Beach Parking," Section 8-2-45, "Obedience to Parking Regulations," Paragraph (p) is hereby amended to include and state the following:

- (p) A. Along the rights-of-way of Palm Boulevard between 21st Avenue and 40th Avenue in any of the following manners:
 - 1..Within four feet (4') of the pavement, except as otherwise posted;
 - 2. In any manner other than angled parking in the designated marked spaces on the land side of Palm Boulevard;
 - 3. In any manner other than parallel parking in the direction of traffic on the ocean side of Palm Boulevard and;
 - 4. Double parking on the passenger side of any vehicle that is parallel parked along the right-of-way on the ocean side of Palm Boulevard.

WHEREAS, the Isle of Palms Council now desires to amend Chapter 2, Article A, Article B, and Article C, to ensure the aforementioned objective.

BE IT ORDAINED AND ENACTED BY THE MAYOR AND COUNCIL MEMBERS OF THE CITY OF ISLE OF PALMS, SOUTH CAROLINA, IN CITY COUNCIL ASSEMBLED THAT TITLE 8, CHAPTER 2 SHALL BE AMENDED AS FOLLOWS. ALL SECTIONS OF TITLE 8, CHAPTER 2 NOT REFERENCED REMAIN UNALTERED.:

- SECTION 1. That Article A, "General Provisions," Section 8-2-2, "General Prohibitions," Paragraph (1) (t) is hereby amended to include and to state the following:
 - (t) A. Along the rights-of-way of Palm Boulevard between 21st Avenue and 40th Avenue in any of the following manners:
 - 1. Within four feet (4') of the pavement, except as otherwise posted;
 - 2. In any manner other than angled parking in the designated marked spaces on the land side of Palm Boulevard;
 - 3. In any manner other than parallel parking in the direction of traffic on the ocean side of Palm Boulevard and;
 - 4. Double parking on the passenger side of any vehicle that is parallel parked along the right-of-way on the ocean side of Palm Boulevard.
 - B. Along the rights-of-way of Palm Boulevard between 42nd and 53rd Avenue in any of the following manners:
 - 1. Within four feet (4') of the pavement, except as otherwise posted;
 - 2. In any manner other than parallel parking in the direction of traffic; and

- 3. Double parking on the passenger side of any vehicle that is paralleled parked along the right-of-way.
- SECTION 2. That Article B, "Resident Parking Districts," Section 8-2-31, "Obedience to parking regulations," Paragraph (a) (16) is hereby amended to include and state the following:
 - (16) A. Along the rights-of-way of Palm Boulevard between 21st Avenue and 40th Avenue in any of the following manners:
 - 1.. Within four feet (4') of the pavement, except as otherwise posted;
 - 2. In any manner other than angled parking in the designated marked spaces on the land side of Palm Boulevard;
 - 3. In any manner other than parallel parking in the direction of traffic on the ocean side of Palm Boulevard and;
 - 4. Double parking on the passenger side of any vehicle that is parallel parked along the right-of-way on the ocean side of Palm Boulevard.
 - B. Along the rights-of-way of Palm Boulevard between 42nd and 53rd Avenue in any of the following manners:
 - 1. Within four feet (4') of the pavement, except as otherwise posted;
 - 2. In any manner other than parallel parking in the direction of traffic; and
 - 3. Double parking on the passenger side of any vehicle that is paralleled parked along the right-of-way.

SECTION 3. That Article C, "Beach Parking," Section 8-2-41, "Definitions" is hereby amended to include and state the following:

Angled parking shall mean parking of a vehicle in a delineated parking space aligned at an angle not exceeding sixty (60) degrees.

SECTION 4. That Article C, "Beach Parking," Section 8-2-45, "Obedience to Parking Regulations," Paragraph (p) is hereby amended to include and state the following:

- (p) A. Along the rights-of-way of Palm Boulevard between 21st Avenue and 40th Avenue in any of the following manners:
 - 1..Within four feet (4') of the pavement, except as otherwise posted;
 - 2. In any manner other than angled parking in the designated marked spaces on the land side of Palm Boulevard;
 - 3. In any manner other than parallel parking in the direction of traffic on the ocean side of Palm Boulevard and;
 - 4. Double parking on the passenger side of any vehicle that is parallel parked along the right-of-way on the ocean side of Palm Boulevard.
 - B. Along the rights-of-way of Palm Boulevard between 42nd and 53rd Avenue in any of the following manners:


- 1. Within four feet (4') of the pavement, except as otherwise posted;
- 2. In any manner other than parallel parking in the direction of traffic; and
- 3. Double parking on the passenger side of any vehicle that is paralleled parked along the right-of-way.




SECTION 6. That all ordinances or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as the same affect this Ordinance.






