Accommodations Tax Advisory Committee

11:00 a.m., Wednesday, May 22, 2019

The regular meeting of the Accommodations Tax Advisory Committee (ATAX) was held at 11:00 a.m., Wednesday, May 22, 2019, in Council Chambers of City Hall, 1207 Palm Boulevard, Isle of Palms, South Carolina. Attending the meeting were Committee members Burgis, Haynie, Muhlig, Nelson, Spell and Williamson, Interim City Administrator Fragoso, Treasurer Suggs and Clerk Copeland; Ms. Miller was absent, but a quorum of members were present to conduct business.

1. Acting Chair Nelson called the meeting to order and acknowledged that the press and public were duly notified of the meeting in accordance with the Freedom of Information Act.

2. Approval of Previous Meeting's Minutes

MOTION: Mr. Burgis moved to approve the minutes of the regular meeting of November 14, 2018 ass submitted; Ms. Haynie seconded and the motion PASSED UNANIMOUSLY.

3. Citizens' Comments – none

4. Financial Statements

Treasurer Suggs reported that revenue from State Accommodations Taxes were in-line with previous years and possibly higher. In reviewing expenditures of ATAX funds by the various departments in the City, the Treasurer noted that all were below budget except General Government that was on-budget, and the FY19 ATAX budget was three hundred forty-eight thousand dollar (\$348,000) ahead. The fund is forecasted to end the year with a balance of approximately one million six hundred thousand dollars (\$1,600,000).

- 6. New Business

A. Sponsorship of Carolina Coast Surf Club website in the amount of \$1,000

Jim Radley was present representing the Surf Club and noted that, if approved, this would be the fifth time the City has supported their website. The site contains a constantly updating surf report and links to the IOP website for parking regulations and SC511 for traffic updates; it also is linked to the traffic cameras for the IOP Connector.

MOTION: Ms. Spell moved to approve the \$1,000 sponsorship of the Carolina Coast Surf Club website; Mr. Williamson seconded and the motion PASSED UNANIMOUSLY.

B. Sponsorship of S.C. Aquarium 20196 Turtle Trek in the amount of \$10,000

Stephanie Gabosch, Officer in Strategic Partnerships for the SC Aquarium, told the Committee that this was the fourth year that the Turtle Trek has been at the Isle of Palms, and this year looks to be bigger and better than 2018. The event is scheduled for Saturday, September 21st beginning at 4:00 p.m. with a beach sweep, and Wild Dunes is offering participants a special room rate and

will run a shuttle between the hotel and Front Beach. Due to parking issues, the number of participants has been capped at six hundred (600); last year, seven hundred (700) participants between the ages of one and seventy-eight (1 - 78) came from twenty-five (25) states and Canada to be a part of the festivities.

MOTION: Ms. Spell moved to approve a sponsorship in the amount of \$10,000 for the 2019 Turtle Trek; Mr. Burgis seconded and the motion PASSED UNANIMOUSLY.

C. Review of and adoption of the FY20 ATAX budget

Treasurer Suggs stated that, based on historical trends, the ATAX revenue is budgeted to increase by three percent (3%), and the new hotel in Wild Dunes will be a new source of revenue. The budget for General Government is projected to increase by four percent (4%) due primarily to the increased amount due to the CVB from the increased revenue.

Included in the FY20 ATAX budget is five hundred thousand dollars (\$500.000) from the Fire Department and an equal amount from the Police Department toward the remediation of the Public Safety Building. The investigative work on the building has been completed, and Trident Construction has estimated the total cost to rehabilitate it is approximately six point two million dollars (\$6,200,000). This estimate includes approximately six hundred thousand dollars (\$600,000) to replace those things that have reached the end of their useful life; their recommendation is to remove the siding and the roof to seal the building tightly. The City has accumulated the four million dollars (\$4,000,000), the earlier estimate; one million dollars (\$1,000,000) will come from ATAX, another million (\$1,000,000) from Municipal Accommodations Tax and two million (\$2,000,000) from the General Fund. The City will issue a General Obligation (GO) bond for the remaining two point two million dollars (\$2,200,000). Responding to Ms. Muhlig, the Treasurer stated that one hundred thousand dollars (\$100,000) is in the budget for offices for personnel while the building is under construction. When Ms. Spell asked about the proceeds from the lawsuit, Treasurer Suggs replied that the money was held in the General Fund and earmarked for this rehabilitation project. To pay for the 75' foot ladder truck, the City will enter into a municipal lease with the debt to be serviced with ATAX funds budgeted for the Fire Department. The City will obtain a revenue bond for the dock replacements along Morgan Creek and dredging in the amount of four million dollars (\$4,000,000), and ATAX funds will service that debt at approximately three hundred thousand dollars (\$300,000) a year. The original intent was to phase the dock replacements over five (5) years, but they have reached such a state of disrepair that they are not safe, and ATM has recommended that they be replaced at one time and sooner rather than later. Assuming that the City receives the permits early in 2020, the construction should take place in the fall and winter of 2020 and take four to five (4 - 5) months. In the ATAX budget for the Front Beach and public restrooms, the funding for contracted services has been increased in anticipation of a new contractor for the daily upkeep of the restrooms.

MOTION: Ms. Haynie moved to approve the FY20 ATAX budget as presented; Mr. Burgis seconded and the motion PASSED UNANIMOUSLY.

Treasurer Suggs cautioned the Committee that a fourth version of the budget would be forthcoming and that the numbers could change.

Osceola's Muse is an interactive theatre event, which will be performed at Battery Gadsden on Sullivan's Island, October 11, 12, 18, & 19 with a special school performance for students at Sullivan's Island Elementary School on October 18th. Sullivan's Island where Osceola is buried. The overgrown remnants of Fort Moultrie batteries give an inkling of the conditions he and his tribe endured while prisoners there. Fables of his bravery and leadership blow on the sea breezes as historians continue to debate the issues of deceit and heroism that framed this important part of South Carolina history. In benefit of the Battery Gadsden Cultural Center, this pivotal historic episode will be dramatized within the Fort

Moultrie battery where the tribe was held captive and will include live actors, music, artifacts, original costumes and scenery along with audience interaction.

Osceola's Muse is a collaboration between PURE Theatre, visual artist, Jonathan Green, Keepers of the Word, Native American musician Delia Chariker, The Gullah Society, and producer Carol Antman. The story's themes are galvanizing: forced migration, assimilation, racism and cultural misunderstanding. Using artistic license, *Osceola's Muse* will juxtapose authentic history with spectacle to provide an entertaining experience that is historically based and enlightening.
