MINUTES

1. Call to Order

Present: Council members Bogosian, Ward and Carroll

Staff Present: Administrator Kerr

2. Approval of Previous meeting's minutes

MOTION: Council Member Carroll made a motion to approve the minutes of the November 13, 2025 meeting. Council Member Ward seconded the motion. The motion passed unanimously.

3. Old Business – Interview candidates for Boards and Commissions

Mr. Greg Force would like to be on the Beach Preservation Committee. He is a geologist who has some experience and knowledge of hard structures on the beach. He believes seawalls are the worst thing to add to a beach.

Mr. Kent Stair interviewed for the opening on the Board of Zoning Appeals. He is retired but practiced law for 49 years. He was appointed to the State Board of Registration for Engineers and Land Surveyors, which Administrator Kerr believes will keep him from serving on IOP's BOZA.

Ms. Alice Bova also interviewed for a position on the Beach Preservation Committee. Ms. Bova was a nurse for 33 years and was raised in a very environmentally conscious family. She believes the biggest issue is the amount of money that is spent constantly refurbishing the beach. She expressed concern about how much building has happened near the beach.

Mr. Dan Slotchiver, an original member of the Beach Preservation Ad Hoc Committee, would like to serve on the new permanent committee. He said the island is his home and he wants to give his time to make it better. He believes there is much more to be studied to help preserve the beach.

4. Executive Session

Council Member Ward seconded the motion. The motion passed unanimously.

Discussion of parameters for program to recognize long-term Council members

Council Member Ward shared a rendering of silver and gold pins to acknowledge long-serving Council members.
