Call Summary

November 2010

- 11/5/10 Personnel responded to a report of a chimney fire at a residence on Hartnett Boulevard. Upon arrival crew found a small amount of ash burning in the flue. The homeowner had knocked down most of the fire with a garden hose and fire department personnel completed the extinguishment. Crews checked for any fire extension and found none. The area around the fireplace was cleaned up by the fire department and the resident was advised to have the chimney inspected before any further use.
- 11/15/10 Personnel responded to a building on Palmetto Drive for a report of a person stuck in an elevator. Upon arrival crews found a person trapped inside the elevator car on the second floor. Power was shut off to the elevator and then turned back on to reset the system. Once power was restored the doors opened and the person evacuated the elevator. The elevator would not resume normal operation, so personnel shut off the power to the elevator again, identified the elevator as inoperable, and notified property management of the situation. The property manager responded and called in service personnel to handle the matter.
- 11/19/10 Personnel responded to Palm Boulevard for a motor vehicle accident involving a pedestrian. Upon arrival crews found a female patient lying in the road complaining of back pain. Patient care was initiated and the patient was placed on a backboard for transport. Upon their arrival, patient care was turned over to Charleston County EMS Medic 11 for further treatment and transport.

Additional Training

All career personnel received training in policy and procedure, firefighter safety, and high-rise firefighting operations.

All volunteer personnel received training in department policy and procedure, and loss control.

Medical in-service training covered Hemorrhage and Shock, Soft Tissue Trauma, and Trauma Systems and Mechanism of Injury.

Fire Inspector Jeff Anderson completed nine courses of training through the International Association of Arson Investigators. The web-based classes were entitled: "Understanding Fire Through the Candle Experiments;" "Critical Thinking Solves Cases;" "An Analysis of the Station Nightclub Fire;" "MagneTek: A Case Study in the Daubert Challenge;" "Effective Investigation and Testimony;" "Ethics and the Fire Investigator;" "A Ventilation-Focused Approach to the Impact of Building Structures and Systems on Fire;" "Fire and Explosion Investigations: Utilizing NFPA 1033 and 921;" and "Fundamentals of Interviewing."

Captain Fred Tetor and Fire Inspector Jeff Anderson attended a day-long Quarterly Training for Certified Fire Marshals program. They received six hours of training toward their annual recertification requirement of 20 hours. The program was held at the S.C. Fire Academy in Columbia.

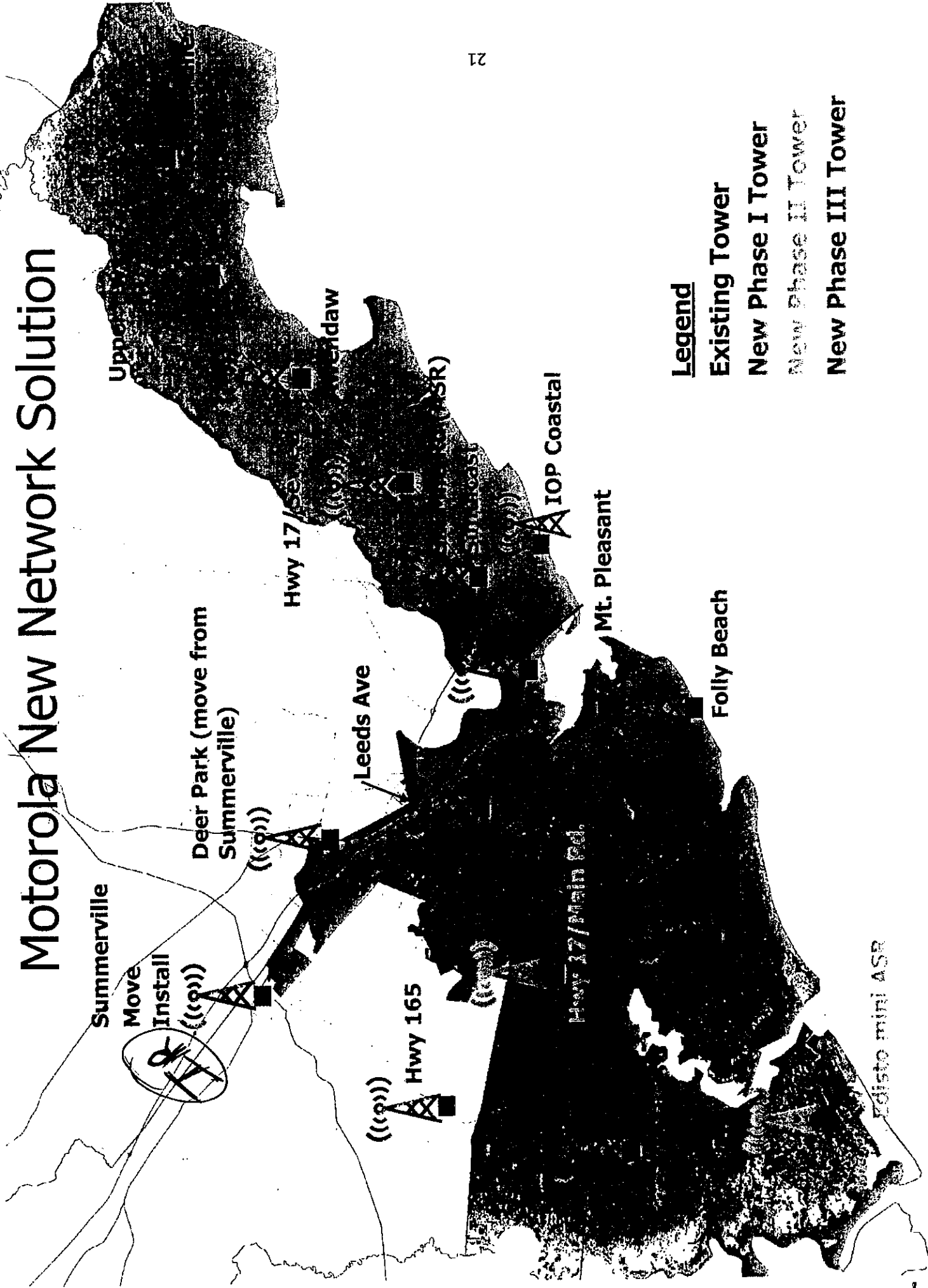
November 30
