The following is a synopsis of some of the activities of the Isle of Palms Police Department during the month of June 2010.

Patrol

June 1, 2010 An officer responded to a local liquor store for a report that an underage male subject had attempted to purchase liquor with false identification. The subject presented an expired license that belonged to another subject. He was charged with Minor Under 21 Attempting to Purchase Liquor.

June 2, 2010 An officer on foot patrol in a local shopping center heard a loud bang from the area of the traffic light at Palm Boulevard and the Connector, then saw a vehicle occupied by several subjects leave the area quickly. The officer went to his vehicle and caught up to the vehicle and observed it enter a driveway on Waterway Boulevard and turn off the headlights. The officer stopped approached the vehicle and determined that the driver had thrown lit fireworks from the window of his vehicle and quickly drove away to a friend's residence. The driver was charged with Unlawful Discharge of Fireworks, Littering, and Careless Operation.

June 4, 2010 An officer on patrol observed a vehicle disregard a stop sign on Carolina Boulevard and when the vehicle was stopped the driver immediately exited the vehicle. The officer immediately detected a strong odor of freshly burned marijuana. The driver admitted that he had been smoking and the marijuana was in the console. The officer located a glass pipe and a container with marijuana. The driver was taken into custody charged with Disregarding a Stop Sign and Simple Possession of Marijuana.

June 5, 2010 An officer on patrol observed an oncoming vehicle cross over the double solid line two times and turned around to stop the vehicle and investigate. The vehicle was stopped after the vehicle was again observed crossing the center- line on Palmetto Drive in Wild Dunes. The driver told the officer that she had been returning from work and provided the wrong paperwork that was requested by the officer. The driver then admitted that she had been drinking since she got off from work. The driver was administered several Field Sobriety Tests which she failed and was taken into custody and transported to police headquarters for a Datamaster Test and refused to provide a sample to the Datamaster Operator. The driver was charged with DUI and transported to the Detention Center.

June 6, 2010 An officer met with a Mount Pleasant police officer, who requested assistance in locating a Criminal Domestic Violence suspect staying at a residence on Palm Boulevard. The subject was located and left with the Mount Pleasant officer.

June 8, 2010 Just after 2 A.M., an officer on patrol stopped a vehicle on the Connector traveling with four way flashers activated and no other lights. While speaking to the driver, the officer observed marijuana in plain view on the console of the vehicle, and then determined that the driver did not have his driver's license with him. The officer advised that the vehicle would need to be towed, since it was unsafe to operate the vehicle without lights. When the driver was asked to exit the vehicle he immediately did so and quickly locked it to keep the officer from seizing the marijuana. Located in four areas of the vehicles interior was marijuana and drug paraphernalia. The driver was charged with Simple Possession of Marijuana, No SCDL in Possession and No Tail Lights.

June 9, 2010 An officer on foot patrol on the Front Beach encountered a male subject urinating in a parking area under a hotel. The subject was under the influence of alcohol and charged with Disorderly Conduct.

June 10, 2010 Just after 1 A.M., an officer on foot patrol of the Front Beach observed a male subject on the sidewalk who appeared to be urinating. When the subject saw the officer approach he tossed a clear plastic baggie behind him as he responded to the officers presence. The subject then began to quickly walk away from the officer. The officer caught up to the subject and apprehended him. The officer immediately detected a strong odor of marijuana coming from the subject's, who admitted that he had some marijuana in a bag on his belt. A quantity of marijuana was in the bag, along with several other illegal substances. The plastic bag that was thrown by the subject was retrieved and found to have several small bags of white powdery substance. Once the subject was arrested and placed in the rear of a police vehicle, several of his friends began to gather. They were asked to leave, but one subject came back several times interfering with the investigation to a point where he was taken into custody and charged with Hindering. The subject with the drugs was transported to police headquarters for processing and was charged with Resisting Arrest, Simple Possession of Marijuana, Possession of Cocaine with the Intent to Distribute, and Trafficking in Methamphetamine, and was later transported to the Detention Center.

June 12, 2010 Police responded to the Municipal Parking Lot after numerous citizens reported an assault in progress. Upon arrival, several citizens pointed to an SUV attempting to leave the parking lot, which was reportedly driven by the suspect. The vehicle, which was occupied by two male subjects was stopped and both were detained until it was determined that the driver was the suspect in the assault. The incident began between two male subjects, the suspect and the victim, who had a verbal altercation while walking from the beach to the parking lot. Once in the parking lot, the altercation escalated to a shouting match, which resulted in some punches being thrown, and culminated when the suspect went into his vehicle and retrieved a wooden baseball bat and struck the male subject he had been arguing with in the head causing him to fall to the ground. Several witnesses stated that once the victim fell to the ground the suspect then struck the victim 10-15 times about the head and shoulders, then quickly attempted to exit the parking lot. A second male victim, who fled the area was later located and needed medical assistance for a broken arm and ribs. The victim that had been on the ground staggered to Ocean Boulevard near 14th Avenue to summon assistance. An officer located the victim who was treated on scene by fire department personnel and transported to MUSC by EMS. The suspect was arrested for the aggravated assault and transported to police headquarters for questioning. Written statements were taken from numerous witnesses, which confirmed the incident was solely between the suspect and the two victims, with no additional involvement from anyone else. The suspect was charged with Attempted Murder and Minor in Possession of Beer and transported to the Detention Center.

June 13, 2010 Just after 2 A.M., an officer on patrol stopped a vehicle for an equipment violation and while checking the occupants of the vehicle determined that a passenger was wanted by the Berkeley County Sheriff's Office. The subject was taken into custody and placed in the rear of a police vehicle to await confirmation of the warrant from Berkeley County. Minutes later, the officer checked on the subject and determined that he had deliberately urinated in the rear seat of the vehicle. He was charged with Malicious Damage to City Property and turned over to the custody of a Berkeley County Sheriff's Deputy.

June 14, 2010 Officers responded to the Boardwalk Inn in Wild Dunes where management reported a domestic dispute in one of their guest rooms. Upon the officer's arrival, management advised that the husband had just left the premises and provided a vehicle description. Officers met with the wife in her room, who stated that an argument escalated to a point where she retreated to the bathroom and he forced his way through the door then pushed her against the wall then to the floor causing a head injury. The assault then moved to the living area where he continually shoved her onto the couch. She was able to retreat to an outside balcony where he attempted to close and lock the door. The victim was able to call building security, which resulted in her husband quickly exiting the premises. Fire Department personnel treated the victim until EMS arrived. The victim was transported to East Cooper Medical Center for treatment. The suspect was located within a few minutes parked in a vehicle at the Island Center where he was taken into custody charged with Criminal Domestic Violence.

June 15, 2010 After stopping a vehicle on Ocean Boulevard for an equipment violation, the officer made the determination that a passenger in the vehicle was wanted by the Charleston County Sheriff's Office for Contempt of Court. He was taken into custody and turned over to a Charleston County Deputy.

June 15, 2010 Just before midnight, an officer on patrol stopped a vehicle on Palm Boulevard for speeding. While the officer was speaking to the driver she observed a half empty bottle of vodka in the floorboard of the vehicle. The driver was charged with Speeding and Illegal Transport of Legal Liquor.

June 19, 2010 Just before 2 A.M., an officer on patrol stopped a vehicle for an equipment violation on Palm Boulevard near 21st Avenue. While speaking to the driver, the officer detected an odor of alcohol and observed the driver to be overly nervous and fidgety. A second officer present observed the driver attempting to conceal a false identification with his right hand. A computer check of the driver revealed that his license was suspended for seven unpaid traffic tickets. A quantity of marijuana and drug paraphernalia was located in a bag. The driver was taken into custody charged with DUS, Lend, Borrow, Steal License Plate, No Insurance, NRVC 7 counts, and Simple Possession of Marijuana 3rd Offense then transported to the Detention Center.

June 20, 2010 An officer responded to a Front Beach business where a theft had been reported. An employee of the business was outside with the suspect who met the officer and identified the female subject who had stolen a necklace. The suspect admitted to the theft and was charged with Shoplifting and transported to the Detention Center.

June 21, 201 Just before 2 A.M., an officer on patrol on the Connector observed a vehicle traveling in front of him weaving significantly and leaving the lane of travel several times. After stopping the vehicle the officer detected a strong odor of alcohol from within the vehicle. The driver was administered several Field Sobriety Tests and taken into custody and transported to headquarters for a Datamaster Test. After going though the entire process the driver refused to provide a breath sample or to sign any paperwork. He was charged with DUI and transported to the Detention Center.

June 21, 2010 At 11:30 P.M., an officer on patrol of Ocean Boulevard observed several trash cans and mailboxes on the ocean side of the street knocked down. The officer then observed a male juvenile, who disappeared when he saw the officer turn around. Minutes later, the officer again observed the subject, who ran away toward the beach on a beach access path. The subject was apprehended and taken into custody and found to be thirteen years old. Minutes later, a second officer located another male juvenile hiding in some bushes on Ocean Boulevard where he too was taken into custody. Both subjects had consumed alcohol and were responsible for knocking down at least eight mailboxes and many more trash cans. Both subjects were visiting from Saluda, South Carolina and since both are juveniles, their case will be handled in Family Court. They were both charged with Disorderly Conduct, Minor With Illegal Consumption of Alcohol, Underage

Possession of Tobacco, and at least 8 counts of Malicious Damage to Property. Both were later released to family members.

June 23, 2010 An officer on patrol stopped a vehicle for an expired license plate on Ocean Boulevard near JC Long Boulevard. While speaking to the occupants, the officer observed a pill bottle with no label in plain view and investigated. The officer located a black drawstring bag, which contained another pill bottle with the label removed, which contained marijuana. Another container in the bag contained a quantity of loose prescription medication identified as Adderall and Viagra. The driver was charged with Possession of Schedule II Controlled Substance, Simple Possession of Marijuana, Expired Registration, and Unlawful Carrying of Prescription Drugs Outside Original Container.

June 24, 2010 Sometime after 2 A.M., officers were alerted to the fact that two male subjects had just left an Ocean Boulevard residence, after unlawfully entering the residence then assaulting at least two subjects while inside. A description of the suspects and their vehicle was provided and stopped minutes later on 14th Avenue near Palm Boulevard. The two male suspects were positively identified as the persons who had just left the residence. After the facts of the incident were sorted out and statements obtained, the two suspects that were stopped in the vehicle were each charged with Burglary 3rd degree. One suspect was also charged with Assault & Battery 1st degree and Malicious Damage to Property. Both were transported to the Detention Center to await a Bond Hearing.

June 24, 2010 Officers responded to the Citadel Beach House regarding an assault that had just occurred with additional information that the suspect had just left the area in a vehicle. The suspect was located and stopped while officers made the determination that an assault had occurred and positive identification had been confirmed. The incident happened after the caretaker and a guest had a verbal altercation, which resulted in the suspect grabbing the caretaker. The guest was charged with Simple Assault.

June 26, 2010 Just before 11 P.M., an officer stopped a vehicle on Palm Boulevard for Speeding and while approaching the vehicle observed five occupants with open containers of alcohol in plain view. All five occupants were determined to be underage to possess alcohol. The driver was charged with Careless Operation and all five were charged with Underage Possession of Beer and Open Container in a Motor Vehicle. All five subjects resided out of state.

June 27, 2010 An officer responded to a JC Long Boulevard restaurant, where management reported a patron who was asked to leave several times and had refused to do so. When the subject finally left the premises, he tore up several decorative plants in the front entranceway. The officer met management, who identified the subject in question, who was now in the parking lot. The officer met the subject who appeared to be extremely intoxicated and unable to care for himself and placed him under arrest for Public Intoxication and Malicious Damage to Property.

June 27, 2010 An officer traveling across the Connector stopped to check on the welfare of a South Carolina Highway Patrol Trooper who was out on a traffic stop. The trooper was in the process of arresting the driver for DUI and requested that the officer transport the female passenger to her residence on the Isle of Palms. The officer drove the passenger to her Palm Boulevard residence.

June 27, 2010 Officers responded to a Palm Boulevard residence where a domestic dispute had been reported. Officers met the victim, a 22 year-old female, who stated that her 20 year-old brother had assaulted her during a family dispute. Both were part of a family visiting from Tennessee. The male suspect was taken into custody charged with Assault & Battery 3rd degree.

Personnel/Community Relations

June 4, 2010 At the request of the Commandant of the Marine Corps League Detachment 803, Sgt. Ryan played the Great Highland Bagpipe for the opening ceremony of the Marine Corps League Department of South Carolina Convention at the Embassy Suites Hotel and Convention Center in North Charleston.

June 15, 2010 Chief Buckhannon gave a Letter of Appreciation to Sgt. Erickson, PFCs Chavez and Funsch for their valuable assistance in solving several recent burglaries.

June 15, 2010 Chief Buckhannon gave a Letter of Appreciation to Det. Tarr for assisting an elderly resident who had been taken advantage of by persons renting a home from her. Det. Tarr was able to recover full restitution to the citizen for checks that had been written to her.

June 18, 2010 PFC Baldrick received a letter of appreciation from a couple visiting the Isle of Palms who waved her down for assistance. PFC Baldrick assisted the couple by calling their daughter and waiting until she arrived.

June 21, 2010 Sgt. Jimenez received a letter of appreciation from a local doctor who commended him for his quick response in getting a tourist that had been bitten by a stingray to her urgent care facility.

June 29, 2010 Sgt. Usry and Sgt. Meekins were each recognized for their planning and organization of the police department's portion of the recent Hurricane Expo.

June 30, 2010 For the month of June, officers discovered five businesses and six homes with open or unsecured doors. A total of sixteen Victim of Crime Forms were issued to homeowners for various violations noted, and one hundred eighty six Property Security Check Forms to advise business or homeowners that an officer checked their property during the night.
