The following is a synopsis of some of the activities of the Isle of Palms Police Department during the month of March 2011.

Patrol

March 1, 2011 A Mount Pleasant Police Officer needed to conduct a follow-up investigation with a resident of Myrtle Boulevard and requested that an Isle of Palms officer be present while doing so. The investigation was conducted without incident.

March 1, 2011 An officer stopped a vehicle for an equipment violation and when a computer check of the driver was done, the officer determined that the driver had a suspended license. The driver was charged with DUS, and he was allowed to contact a licensed driver to come and drive the car to his residence.

March 4, 2011 An officer responded to a Palm Boulevard business where a hit and run accident had been reported. A witness provided a good description of the suspect vehicle, which was quickly located and stopped on Waterway Boulevard near 32nd Avenue. The driver was taken into custody and charged with NO DL, Leaving the Scene of an Accident, and No Insurance.

March 5, 2011 An officer responded to an Ocean Boulevard address where a citizen reported there was an intoxicated subject. The officer located a female subject lying in the bushes. The subject was unable to sit up without assistance and slumped over several times while trying to answer the officer. Since she was unable to care for herself, she was taken into custody and charged with Public Intoxication and NRVC 3 counts for three unpaid traffic tickets.

March 5, 2011 An officer on patrol stopped a vehicle on Palm Boulevard for an equipment violation and while speaking to the driver detected a strong odor of burned marijuana coming from within the vehicle. The driver admitted that he had smoked marijuana earlier in the day. Located in the center console was a quantity of marijuana and drug paraphernalia. He was charged with Simple Possession of Marijuana and Expired Registration.

March 6, 2011 A vehicle was stopped for disregarding a stop sign on 27th Avenue near Waterway Boulevard. While speaking to the driver, the officer determined that the driver's license was suspended for failure to pay a traffic ticket. The driver was charged with Disregarding Stop Sign, DUS 1st, and NRVC.

March 6, 2011 An officer stopped to speak with two subjects he observed sitting in a parked vehicle, just before 11 P.M. on Palm Boulevard. While speaking to the subjects, the officer determined that the female subject in the driver's seat was intoxicated and unable to perform Field Sobriety Tests. She was charged with Disorderly Conduct.

March 9, 2011 Officers responded to the front beach near JC Long Boulevard where a tour bus belonging to a band scheduled to perform at the Windjammer, caught on fire. Fire Department personnel responded and extinguished the blaze, which appeared to have started in the engine compartment. It is believed that the damage will result in a total loss. Police personnel cordoned off the area to traffic to allow a safe distance from the area.

March 9, 2011 An officer responded to a residence on Oak Harbor Boulevard regarding a guest living in the residence who was no longer welcome. Rather than going through the eviction process, the unwanted guest gathered her personal belongings and left without further incident.

March 11, 2011 An officer stopped a vehicle on Palm Boulevard for an equipment violation and determined that the license plate was suspended for cancellation of insurance. It was then determined that the driver's license was also suspended. The driver was charged with DUS 1st, No Insurance, and Failure to Surrender License Plate.

March 12, 2011 A Wild Dunes Security Officer observed a subject shoot a BB gun at a parked vehicle and when he began to approach the subject about the incident three teenage male subjects ran from the scene. A description of the subjects was broadcast and they were located in the parking lot of the Island Center some time later. At the request of Wild Dunes Security, all three subjects, identified as being 14, 15, and 16 were placed on Trespass Notice to Wild Dunes. All three were released to the custody of a parent.

March 12, 2011 A citizen approached an officer in the parking lot of the Island Center to report that she had just pumped fuel into the fuel tank of her vehicle at the convenience store. She then noticed a strong smell of gasoline coming from within the vehicle. It was determined that gasoline was spilling from the rear of the vehicle onto the pavement. The Fire Department was summoned and responded and cleaned up the spill. The vehicle was towed from the scene.

March 13, 2011 Just before 3:30 A.M., an officer on patrol observed a vehicle stopped at a stop sign in the lane of traffic at Waterway Boulevard and 25th Avenue. After several attempts to awaken the driver, he responded to the officer and appeared disoriented. The subject was taken into custody charged with Public Intoxication and Unlawful Sleeping in a Vehicle.

March 15, 2011 Just before 2 A.M. an officer on patrol of the Front Beach observed two male subjects shouting loudly near a local hotel then observed one of the males urinating in full view of others on the street. The officer approached the subject who was unsteady on his feet and had difficulty keeping his balance. The subject was charged with Disorderly Conduct.

March 15, 2011 An officer on patrol stopped a vehicle for speeding on Waterway Boulevard and determined that both the license plate and the driver's license were invalid in South Carolina. The driver was charged with Failure to Surrender a Suspended License Plate, DUS, and Failure to Obtain a SC DL.

March 19, 2011 An officer responded to a residence on Forest Trail, where a citizen reported that his vehicle parked in the driveway had been vandalized during the night. The officer observed that the vehicle had been spray painted with two separate colors. Less than an hour later, the officer received some information that a party had taken place the previous evening nearby. The officers went to that location and determined that some girls had a sleepover, and four male friends did come over, but left between 11 P.M. and midnight. The officers determined where the two of the male subjects lived and went to that residence and identified two of the four male subjects involved. While speaking to the two boys, who are brothers, both were observed with paint on their clothing and person consistent with the colors on the vandalized vehicle. A can of spray paint was observed in plain view and taken as evidence. These two subjects and their father met with the officer at the Public Safety Building and provided a written statement admitting to their involvement in a total of thirteen incidents of vandalism, to include eight vehicles being spray painted, four damaged mailboxes and a spray painted traffic sign. Two additional male subjects were identified and officers met with them and their parents, where written statements were obtained. All four subjects, who were 10, 12, 13, and 14 years old were each charged with thirteen counts of Malicious Damage to Property and released to the custody of a parent to await Family Court proceedings.

March 19, 2011 Officers responded to the Connector to a multiple vehicle accident. The driver of one vehicle involved stated that the vehicle that caused the accident had left the scene. The suspect vehicle was located and identified and the driver was charged with Following Too Close and Leaving the Scene of an Accident with Bodily Injury.

March 20, 2011 An officer responded to a vehicle on the 4600 block of Palm Boulevard where Fire Department personnel were treating a female subject suffering from an altered mental condition. She was taken into Emergency Protective Custody and transported by EMS to a local hospital for observation.

March 20, 2011 Just before 4 A.M., an officer on patrol stopped to investigate a vehicle stopped on Palm Boulevard near 23rd Avenue with a male subject sleeping behind the steering wheel. The subject was awakened and appeared to be intoxicated. He was taken into custody and charged with Public Intoxication.

March 20, 2011 An officer on patrol stopped a vehicle on Palm Boulevard near 23rd Avenue for a speeding violation. While speaking to the driver, the officer observed the remnants of a marijuana cigarette in the ashtray of the vehicle. The driver was detained and found to be in possession of a quantity of marijuana and drug paraphernalia. The driver was charged with Careless Operation and Simple Possession of Marijuana.

March 21, 2011 Officers met with a Charleston Police Department Detective to serve an Arrest Warrant on an employee of a local restaurant. Management stated that the employee no longer worked there, but the employee had a paycheck that he was scheduled to pick-up later that day. When the subject arrived at the business, officers responded and took the subject into custody. He was turned over to the custody of a Charleston Police Department Detective in Mount Pleasant.

March 22, 2011 Officers and the Fire Department responded to a fire in the marsh near the 8th hole of the Harbor Golf Course. Witnesses reported hearing boys voices in the area just prior to the fire, and Sheriff Cannon who was in the area stated he observed three juvenile males 10 or 11 years old leaving the area where the fire occurred. The juveniles were located and their parents notified. Two of the three admitted to accidentally starting the fire. Due to their young age and understanding that the parents would handle the matter at home, they were not charged. The two boys responsible were 10 and 11 years old.

March 24, 2011 Officers responded to a residence on 25th Avenue where a friend of the ill female resident asked for a welfare check, since she was unable to get the resident to answer her telephone. After officers were unable to get anyone to come to the door, one officer made entry through an unlocked window and located the resident who had been in a deep sleep after taking medication. No other action taken.

March 25, 2011 A Summerville Police Officer stopped a female subject for a traffic violation and discovered that she was wanted by the Isle of Palms Police Department for Petit Larceny. An Isle of Palms officer met the Summerville officer in North Charleston and assumed custody of the subject where she was booked into the Charleston County Detention Center.

March 26, 2011 Officers responded to a three vehicle accident on Palm Boulevard near 24th Avenue and discovered that the driver of one of the vehicles had left the area. Telephone contact was made with the owner of the vehicle and the driver returned to the scene to meet with officers, The driver was charged with No DL, Following Too Close, and Leaving the Scene of an Accident.

March 26, 2011 An officer responded to a local liquor store where a male subject was being detained for attempting to purchase a bottle of vodka. The nineteen year old Mount Pleasant subject was in possession of an altered Florida driver's license. He was charged with Use of Altered DL and Falsification of age to Purchase Alcohol.

March 26, 2011 Officers responded to a residence on Back Court to a report of loud noise coming from that location. The officer met with five subjects at the residence, all identified as nineteen years old and all in possession of beer and liquor. All five subjects were charged with Underage Possession of Alcohol Under 21. All of the liquor and beer was photographed for evidence then destroyed.

March 26, 2011 An officer responded to a Front Beach business that reported four female subjects fleeing the store after failing to pay for several multi-colored bracelets. The subjects then got into a waiting vehicle and left the area. Several minutes later, a Mount Pleasant Police Officer observed the vehicle in question and stopped it on Highway 17. A witness from the store was brought to that location, where the four subjects were positively identified. Two female subjects identified as juveniles were in possession of bracelets and a necklace and two other adult females were also in possession of stolen property. The juveniles were separated from the adults and later turned over to their parents to await Shoplifting charges in Family Court. The two adult subjects were also charged with Shoplifting. All of the property stolen was recovered and returned to the business.

March 30, 2011 Just after 1 A.M., officers responded to a 911 call where the occupants of a Seaside Cottage Lane residence reported noises downstairs as though someone were attempting to break into the residence. The officers made entry through a rear door and immediately located a male subject asleep on the couch. His identity was confirmed when an officer located his identification in a piece of clothing. The subject was taken into custody and charged with Burglary 1st degree.

Personnel/Community Relations

March 2, 2011 and March 30, 2011 PFC Baldrick, who is a certified Child Safety Seat Officer, installed seats for residents who came to the Public Safety Building for assistance.

March 3, 2011 Sgt. Meekins, at the request of Saint Luke's Children's Center in Summerville, the school that his children attends, presented a short Ask First Program to approximately 25 students.

March 11, 2011 Det. Sgt. Caldwell and Det. Tarr met with the Director of Operations of Wild Dunes to discuss Crime Prevention initiatives within the resort.

March 26, 2011 Sgt. Ambas, Sgt. Meekins, ACO Keelan, ACO Fitzpatrick, and TCO Burton met with residents of Wild Dunes at the Wild Dune Property Owners Beach House to register

bicycles and issue dog tags. Forty-six bicycles were registered and twenty-seven dog tags were issued.

March 26, 2011 Chief Buckhannon, Sergeant Usry, Sergeant Caldwell, Mayor Cronin, and Chairman of the Public Safety Committee, Marty Bettelli, attended the CALEA Commission Hearing in Bethesda, Maryland. The department had a favorable hearing for our 3rd Reassessment onsite. At the full commission hearing, the department received our Fourth Advanced Accreditation Award.

March 31, 2011 For the month of March, officers discovered three businesses and three homes with open or unsecured doors. A total of one hundred ten Victim of Crime Forms or Property Security Check Forms were issued to business or homeowners for violations noted, or to advise that an officer on patrol checked their property during the night.


