


NOTABLE EVENTS / CALL HIGHLIGHTS

- 02/01/2021 The Isle of Palms Fire Department is continuing to maintain situational awareness concerning COVID-19. Personal protective equipment supplies are continually inventoried and restocked as needed. Staffing is being maintained with overtime being limited as best as possible.
- 02/08/2021 Fire crews responded to a report of a fuel spill on Palm Boulevard. Approximately four (4) gallons was spilled due to a faulty fuel pump. Fire personnel applied absorbent to the spill in order to clean the area and remove the fire hazard. All units cleared from the scene and returned back to service.
- 02/12/2021 Fire crews responded to a report of a boat that had become stuck on a sandbar in the ocean directly in front of 8 Summer Dunes Lane. Upon arrival, fire personnel found that the two (2) individuals on the boat were not in distress and were actively trying to free their boat from the sandbar. There was no further need from the fire department. All units cleared from the scene and returned back to service.
- 02/14/2021 Fire crews responded to a structure fire on Sullivan's Island. Isle of Palms Fire personnel assisted with fire attack and conducted salvage and overhaul operations. All units cleared and returned back to service.
- 02/27/2021 Fire crews responded to an automobile versus a pedestrian accident on Ocean Boulevard. Upon arrival fire department personnel found that a pedestrian on a skate board had been struck by a vehicle. The patient had injuries that could possibly be life threatening. The patient was transported to the hospital. All units cleared and returned back to service.




INCIDENT TYPE





FEBRUARY MONTHLY ANALYTIC COMPARISONS



RESIDENCY TYPE ANALYTIC COMPARISONS









FEBRUARY MONTHLY TOTAL CALLS

TOTAL CALLS IN WILD DUNES






