The following is a synopsis of some of the activities of the Isle of Palms Police Department during the month of March, 2012.

(March 2: Friday)

A victim reported that he had posted an employment advertisement on craigslist, advertising his services as a handyman and painter. The victim advised the reporting officer that he received an email from a female subject with the name of Sharon Chapman, wanting to hire him to clean her residence and complete a number of chores for her. Through a series of emails with Chapman, it was agreed upon that she would have her accountant authorize a check and have it delivered to the victim. Chapman requested that the victim wire the majority of the money to an alleged furniture company in New Mexico and a portion to an address in Maine, which he did. Several days after the victim deposited the check in his account and wired the requested cash amounts to the aforementioned locations, he was contacted by his financial institution and made aware that they were pursuing charges against him for being in possession of, and passing fraudulent checks. The victim advised his bank of the situation and attempted to contact Chapman. Chapman never returned his emails. The victim, consequently, conducted a Google search for Sharon Chapman, which produced information regarding craigslist alerts for passing fraudulent checks.

(March 5: Monday)

An officer conducting routine patrol in the vicinity of J.C. Long and Palm Boulevard witnessed a driver operating a vehicle in an erratic manner. Upon initiating a traffic stop and during the subsequent preliminary investigation, it was revealed that the driver was under the influence of alcohol. Following the arrest, the subject was transported to the J. Al Cannon Jr. Detention Center and lodged for DUI.

(March 6: Tuesday)

Officers responded to a Front Beach business in reference to a complaint of an intoxicated subject. Upon arrival, the subject was attempting to re-enter the business from which he had just been ejected. The subject actively resisted arrest, however, was eventually detained and transported to the J. Al Cannon Jr. Detention Center. The subject was charged with Public Intoxication and Resisting Arrest.

During a traffic stop for reckless driving, open containers of alcoholic beverages were observed in the passenger compartment of the vehicle. The Officer requested identification for the three occupants to be checked through dispatch. The National Crime Information Center (NCIC) database produced information that one of the passengers had an outstanding arrest warrant out of the Mount Pleasant Police Department.

(March 8: Thursday)

A traffic stop for a seatbelt violation revealed that the operator's driver's license was under suspension for an unpaid traffic citation. The subject was charged accordingly.

(March 9: Friday)

During a traffic stop for reckless driving, the operator of the suspect vehicle displayed physiological indicators of alcohol and/or drug impairment. A subsequent interview revealed that the driver suffered from a medical condition, the symptoms of which mimicked impairment. The driver was transported to East Cooper Medical Center for treatment.

(March 13: Tuesday)

A victim reported that he had made arrangements to rent a condo in Lagoon Villas, to include paying the \$1,400.00 booking fee, on craigslist. After the victim paid the booking fee through his PayPal account, he attempted to contact the renter, with no response. The victim was able to locate the condo's owner, who advised that the unit is not a rental nor has she ever listed it as so on craigslist.

(March 15: Thursday)

An Officer conducting routine patrol in the area of 36th Avenue and Palm Boulevard observed a seatbelt violation. After conducting a traffic stop on the vehicle, it was discovered that the operator of the vehicle did not possess a driver's license and did not have her 8 month old child secured in a safety seat. She was charged accordingly.

(March 17: Saturday)

Officers responded to Seagrass Lane in reference to a domestic dispute. Upon arrival, the Officers did not observe any disturbance occurring at the time. Contact was made with the complainant who stated that her parents were in a verbal altercation at the time she called the police department, and was afraid that the argument would escalate into a physical altercation. Both parties involved in the verbal altercation confirmed that it did not.

An Officer conducted a traffic stop on a vehicle in the 3100 block of Waterway Boulevard in reference to a seatbelt violation. It was learned that the operator's driver's license and vehicle registration were both suspended for cancellation of insurance. The subject was placed under arrest and charged accordingly.

(March 19: Monday)

An Officer met with a victim who reported that his wallet was stolen while he was visiting a local establishment. The victim stated that he received a telephone call from his credit card company advising him that unknown person(s) attempted to use the stolen credit card. The case has been assigned to the Criminal Investigations Division.

(March 20: Tuesday)

A victim reported that unknown person(s) maliciously destroyed newly planted trees/plants on his 53rd Avenue property. Leads and a suspect have developed in this case, both being pursued by the Criminal Investigations Division.

(March 22: Thursday)

An Officer responded to a residence in the 3500 block of Palm Boulevard in reference to a complaint of a theft. Upon arrival, the Officer met with the victim who reported that he had recently purchased four (4) new toilet bowls for his residence. He had stored the items underneath residence, which is an open garage area.

(March 24: Saturday)

Wild Dunes security personnel reported that one of the back entrance gates had been compromised, consequently, causing damage to the electrical mechanisms responsible for raising the gate. Security video footage was collected, and the case has been assigned to the Criminal Investigations Division.

Officers were dispatched to a Forest Trail residence in reference to a fight in progress. Upon arrival, Officers met with the female victim who reported that she had entered her son's bedroom to advise him that his friends needed to leave. The male subject refused and physically assaulted his mother. The male subject was placed under arrest and charged accordingly.

(March 25: Sunday)

Officers responded to a 911 call hand-up that originated from a residence on 32nd Avenue. Once on scene, Officers met with a male subject who stated that he had been engaged in a verbal altercation with his father, who was intoxicated at the time. The son advised Officers that he had called 911 because he was concerned that the verbal argument would escalate to a physical altercation. The parties were separated for the remainder of the day.

(March 27: Tuesday)

A victim reported that her ex-boyfriend gave her permission to store her surfboard on the front porch of his Cameron Boulevard residence, even though they had ended their relationship. However, the victim stated that she was contacted by her ex-boyfriend's mother, who also lives at the Cameron Boulevard residence, and told to remove her surfboard from the property. Shortly thereafter, the victim went to the residence to retrieve her surfboard finding it missing. The ex-boyfriend's mother advised the victim that she did not know where the surfboard was and had assumed that the victim had picked it up. The victim returned, later, with her father who spoke with the ex-boyfriend's mother who then stated that her son probably took it surfing and left it on the beach, from where it was probably stolen. The investigation continues.

(March 28: Wednesday)

An Investigator was dispatched to Ocean Club Villas in reference to stolen property. Upon arrival, the Investigator spoke with the homeowner who reported that a number of televisions and electronic devices had been stolen from her condo. The homeowner stated that she had recently had some construction in her unit, and provided the name of the company that provided the service. The Investigator also obtained the name of the cleaning company that entered the unit, after the construction had been completed and prior to the arrival of the homeowner.

(March 30: Friday)

A victim met with an Officer to report suspicious circumstances, surrounding rental property her had listed on the VRBO. com website. The victim stated that he was contacted by an individual wanting to rent his property and advised him that they were responding to a craigslist posting. The victim advised that he did not list his property on craigslist, however, the photographs and information that he had provided on the VRBO.com website had been duplicated and posted on craigslist with a different contact person. The investigation continues.

An Officer met with a victim at her vehicle, which was parked in a parking space in front of the Sea Cabins. The victim reported that she left her unlocked vehicle to go to the beach and upon returning to her vehicle, discovered that unknown person(s) had entered into her vehicle and removed her wallet from her purse, which had been sitting on the passenger front seat. The investigation continues.

(March 31: Saturday)

A victim reported that she had left her cellular telephone in her rental property while she was away participating in the bridge run. Upon returning, she had observed that housekeeping had cleaned the room, however, her cellular telephone had been stolen from her suitcase.

Patrol

During the month of March, 2012, Officers issued 132 Business Check notices to business owners/employees advising them that the business was found unsecure. There were 89 Victim of Crime forms completed.

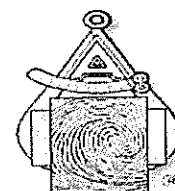
