Isle of Palms Fire Department Call Summary April 2013

- 4/26/13 Personnel responded to a call of a boater in distress in the area of Copahee Sound. Boat 1020 was launched and proceeded to the area to assist. Upon arrival, personnel began attempting to locate the boat. Dispatch then advised that the boater called back and stated they would attempt to return to the City Marina under their own power. After a few minutes the crew met with the caller and they determined that their bilge pump had malfunctioned. After calling for assistance, the boater managed to switch the pump to manual and they were able to start removing water from their boat. Boat 1020 and all personnel returned to the City Marina.
- 4/26/13 Personnel responded to Palm Boulevard in front of the Isle of Palms Water and Sewer Commission office for a small brush fire. Upon arrival, personnel found a small fire smoldering in the pine straw. The crew extinguished the fire with a pressurized water extinguisher. All personnel returned to service.




