The following is a synopsis of some of the activities of the Isle of Palms Police Department during the month of May, 2013.

(May 01: Wednesday)

Domestic Dispute: 41st Avenue. Officers were dispatched to the parking lot of a local business in reference to a domestic dispute. Upon arrival, Officers observed a male and female engaged in a verbal altercation. Both denied the incident of a physical altercation, however, a witness provided statement that he observed the female strike the male subject. Officers checked the male subject's person, finding no physical manifestations of injury. During the investigation, it was determined that the male subject had a suspended driver's license for two active bench warrants for failure to pay traffic fines. Consequently, the male subject was placed under arrest and charged accordingly.

(May 02: Thursday)

Alcohol Violation: 1200 block of Palm Boulevard. An Officer conducting patrol in the 1200 block of Palm Boulevard observed two male subjects walking along the sidewalk; both of whom were carrying cans containing an alcoholic beverage. Both subjects were placed under arrest and charged with No Alcohol on Beach/Streets.

(May 03: Friday)

Traffic Arrest/Driving Under Suspension: 300 block of Palm Boulevard. An Officer conducting patrol in the 100 block of Palm Boulevard observed a vehicle traveling at what appeared to be at a high rate of speed. A traffic stop was conducted after confirming the speeding violation through in-car RADAR. It was determined that the driver's license of operator was suspended for failure to maintain insurance. The subject was placed under arrest and charged with driving under suspension and speeding.

(May 04: Saturday)

Traffic Arrest/Open Container: S. C. 517/Isle of Palms Connector. An Officer conducted a traffic stop after observing an equipment violation. While obtaining information from the driver, the Officer observed an open container of beer within the vehicle, and in immediate control of the driver. Through further investigation, it was determined that the operator of the vehicle did not possess a driver's

license. The subject was placed under arrest and charged with no driver's license, open container and defective equipment.

Simple Assault: 44th Avenue. Officers responded to a residence on 44th Avenue in reference to an assault in progress. Upon arrival, Officers observed a male subject lying on the ground with several family members restraining him. Through interviews and investigation, it was learned that the male subject had been verbally threatening to kill family members and behaving in an aggressive manner by physically assaulting his brother. Due to the subject's behavior, and military training, several family members detained the subject, in fear that the threats would escalate. While detaining the subject, he bit one of the restraining family members. The subject was placed under arrest and charged with assault and battery, 3rd degree.

(May 05: Sunday)

Petit Larceny: 600 block of Ocean Boulevard. The victim reported that unknown suspect(s) stole a docking station from his rental house. There were no apparent indications that forced entry was made into the residence.

(May: 07 Tuesday)

Fraud: 2200 block of Hartnett Boulevard. A complainant advised that unknown suspect used his credit card number to make fraudulent purchases via the internet.

Traffic Arrest/Driving Under Suspension: Palm Boulevard/53rd Avenue. While patrolling the area of Wild Dunes Gate 2 entrance/exit, an Officer observed a vehicle disregard a stop sign in addition to an equipment violation. Upon conducting a traffic stop, it was learned that the operator of the vehicle had a suspended driver's license. The subject was placed under arrest and charged with driving under suspension, third offense.

(May 08: Wednesday)

Traffic Arrest/Open Container: 3000 block of Palm Boulevard. An Officer conducting patrol in the 3000 block of Palm Boulevard observed a vehicle with equipment violations. A traffic stop was conducted, during which time it was learned that the driver did not possess a valid license. The subject was placed under arrest. During a pre-tow inventory of the vehicle, an open container of an alcoholic beverage was located within immediate reach of the driver. The subject was charged with no driver's license and open container.

(May 09: Thursday)

Traffic Arrest: 200 block of Grand Pavilion. An Officer conducting patrol in the 200 block of Grand Pavilion observed a seatbelt violation and conducted a traffic stop on the suspect vehicle. During the stop, it was determined that the operator of the vehicle had an outstanding bench warrant for failure to pay a traffic fine.

(May 11: Saturday)

Alcohol Violation: Ocean Boulevard/Pavilion Drive. An Officer was dispatched to the front beach area in reference to an intoxicated pedestrian. The responding Officer located the subject sitting in the front seat of her vehicle. While speaking with the subject, the Officer detected a strong smell of alcoholic beverage emitting from the subject's person. She was placed under arrest for public intoxication.

(May 12: Sunday)

Narcotics Violation: Waterway Island Drive. Officers were dispatched to Waterway Island Drive in reference to a reckless driver. Upon arrival in the area, Officers located the suspect vehicle by the vehicle description and license plate number provided by the complainant, sitting in a driveway. Officers made contact with the two subjects occupying the vehicle, at which time the Officers detected a strong odor of burnt marijuana. A search of the vehicle produced a quantity of marijuana.

Assault: 1000 block of Ocean Boulevard. Officers were dispatched to the front beach area in reference to an assault that had just occurred. Upon arrival, Officers made contact with a male and female subject who reported that they had been assaulted by a group of subjects they had encountered while on the beach. According to the victims, while walking on the beach, they stopped to ask for directions from three males and a female subject at which time the subjects assaulted them. A search of the area produced no suspects. The victims, received medical attention for minor lacerations from first responders.

(May 13: Monday)

Traffic Arrest: Intracoastal Court/Waterway Boulevard. Officers conducting patrol in the area of Intracoastal Court and Waterway Boulevard observed a subject operating a white utility van, disregard a stop sign. After conducting a traffic stop and identifying the operator, it was determined the subject did not possess a driver's license.

Traffic Arrest/Driving Under Suspension: S. C. 517/IOP Connector. While conducting patrol on the Isle of Palms Connector, an Officer observed a traffic violation and conducted a traffic stop on the suspect vehicle. While speaking with the operator, it was learned that his driver's license was suspended. The subject was charged with driving under suspension and speeding.

(May 17: Friday)

Theft From Motor Vehicle: 1300 block of Ocean Boulevard. The victim reported that unknown person(s) entered into his vehicle and stole an iPod car adaptor.

Petit Larceny: 31st Avenue. The victim reported that unknown suspect(s) stole a bicycle from her unsecured garage.

Grand Larceny: 200 block of Forest Trail. The victim reported that a pearl necklace was stolen from within her residence. Potential suspects have developed in this investigation.

(May 18: Saturday)

Traffic Arrest/Driving Under The Influence: Palm Boulevard/Charleston Boulevard. While conducting patrol in the area of Palm and Charleston Boulevards, an Officer observed a vehicle traveling at what appeared to be at a high rate of speed. After confirming the violation, the Officer conducted a traffic stop on the suspect vehicle. After a post-stop investigation, it was determined that the driver's faculties were impaired. The subject was charged with driving under the influence.

Underage Possession of Alcohol: 1200 block of Palm Boulevard. An Officer made contact with two subjects occupying a vehicle with extensive front damage. While conducting an on-scene investigation for unsafe vehicle, the Officer observed a strong smell of alcoholic beverage emitting from the subjects, and it was learned that the subjects were in possession of alcoholic beverages in spite of being under the legal age of 21. Both subjects were charged with minor in possession of beer.

Traffic Arrest: 6th Avenue/Carolina Boulevard. An Officer conducted a traffic stop for an equipment violation. Upon making contact with the operator, it was learned that he did not possess a valid license.

(May 20: Monday)

Traffic Arrest: Ocean Boulevard/6th Avenue. An Officer conducted a traffic stop for an equipment violation. During the stop, the operator could not produce a valid driver's license, proof of ownership or proof of insurance. The subject was charged accordingly.

(May 21: Tuesday)

Criminal Domestic Violence: 3400 block of Hartnett Boulevard. The victim reported that her live-in boyfriend assaulted her by pouring hot coffee on her, and kicking her in the leg.

(May 22: Wednesday)

Vandalism: 200 block of Charleston Boulevard. The victim advised responding Officers that an unknown subject knocked over his mailbox.

Simple Assault: 7000 block of Palmetto Boulevard. A victim reported that his girlfriend assaulted him by striking him with an open hand, about his facial region.

(May 24: Friday)

Petit Larceny: 600 block of Carolina Boulevard. A victim reported that unknown subject(s) stole her roll-out recycling bin.

Burglary: 55th Avenue. A witness reported that he observed two suspects enter in the residence through a garage door. Officers arrived on scene and tactically cleared the unsecured residence, finding no suspects inside the residence. While conducting a secondary search of the perimeter, two skateboards were located under a bush in the front of the residence, of which did not belong to the residence.

(May 25: Saturday)

Assault, 1st Degree: Intercostal Court. A victim reported that a friend assaulted him during an argument over \$10.00 he owned the subject.

Burglary: Sand Crab Court. A victim advised that unknown person(s) stole his ladder from his boat that was parked in his garage.

Underage Possession of Alcohol: 4100 block of Waterway Boulevard. Officers conducting patrol in the area of Waterway Boulevard and 41st Avenue observed a subject that appeared to be underage, carrying a partial case of Bud Light beer. The Officers confirmed the subject to be under the legal age of 21 years of age and charged him accordingly.

Criminal Domestic Violence: Grand Pavilion Boulevard. Officers responded to the area of Grand Pavilion in reference to a possible drunk driver. The complaint called the police to report that his wife, whom he believed to be intoxicated, had left their room with intentions of retrieving her vehicle and leaving the property. The female subject was located occupying her vehicle in the Sweetgrass Pavilion parking lot. An Officer pulled behind the suspect vehicle to obtain license plate information to conduct a traffic stop, at which time the driver backed into the police vehicle. No damaged was sustained to either vehicle.

During the on-scene investigation, the female subject admitted to having consumed alcoholic beverages, however, could not stay in the room with her husband, as a verbal altercation between the couple resulted in him closing her arm in a glass-sliding door. Due to the apparent physical manifestation of injury, contact was made with the male subject, who was subsequently placed under arrest and charged with criminal domestic violence.

(May 26: Sunday)

Traffic Offense Arrest: 1000 block of Ocean Boulevard. Officers responded to a front beach business in reference to a verbal altercation, in progress, between a male and female subject. Upon arrival, and identifying both subjects, it was determined that the male subject had two outstanding bench warrants for failure to pay traffic fines. The subject was placed under arrest and transported to the Charleston County Detention Facility.

Narcotics Violation: 2100 block of Palm Boulevard. An Officer was dispatched to the 2100 block of Palm Boulevard in reference to a reckless driver. Upon arrival in the area, the suspect vehicle was located and a traffic stop was initiated. The operator did not possess a valid driver's license and was placed under arrest. During a search of the subject's person, incident to arrest, a quantity of a green, plant-like material (GPM) was located in his pants pocket. The GPM field-tested presumptive positive for Tetrahydrocannabinol (THC/the active ingredient found in marijuana).

(May 27: Monday)

Disorderly Conduct/Alcohol Violation: 1100 block of Ocean Boulevard. Officers were dispatched to the front beach area in reference to an intoxicated subject, passed out on the boardwalk access to the beach. Upon arrival, Officers located the subject on the beach and found him to be grossly intoxicated. The subject was placed under arrest and charged with public disorderly conduct.

Traffic Arrest/Driving Under Suspension: 2600 block of Waterway Boulevard. An Officer conducting patrol on Waterway Boulevard observed a vehicle that appeared to be traveling at a higher rate of speed than that of the posted 25 mph. After confirming a speeding violation, a traffic stop was conducted. During the stop, it was determined that the operator's driver's license was suspended. The operator was charged with driving under suspension and speeding.

Traffic Arrest/Driving Under The Influence: 41st Avenue. Officers were dispatched to the marina in reference to a collision. Upon arrival, it was determined that one of the operator's involved in the collision was impaired, due to intoxication. The subject was placed under arrest and charged with driving under the influence.

Suspicious Circumstances/Weapons Violation: Pavilion Drive/Ocean Boulevard. An Officer conducting patrol of the front beach area observed a large number of individuals exiting the beach access path at Pavilion Drive and Ocean Boulevard, in what appeared to be a panic state; and hearing several screaming "he's got a gun". A witness reported that a black male subject was standing on the access path, pointing a gun at the crowds. A suspect, his clothing and vehicle descriptions were provided to all Officers conducting a search of the area. The information was also provided to agencies within surrounding jurisdictions.

(May 28: Tuesday)

Burglary: 37th Avenue. The victim reported that unknown person(s) had stolen some jewelry from his unsecured rental property.

(May 29: Wednesday)

Petit Larceny: 32nd Avenue. The victim reported that unknown person(s) entered into her residence and stole her prescription medication.

(May 30: Thursday)

Petit Larceny: 2300 block of Palm Boulevard. A victim reported that unknown subject(s) stole three surfboards that he had left unsecured in the rear of his residence.

Fraud/Identity Theft: Sparrow Drive. The victim reported that unknown person(s) entered into her unsecured vehicle and stole her BP credit card. The victim was notified of four potential fraudulent charges that had been made in the Mount Pleasant area.

Burglary: 100 block of Charleston Boulevard. A victim advised the reporting Officer that unknown person(s) stole some jewelry from within her residence.

Patrol

During the month of May 2013, Officers issued nine (9) Business Check notices to business owners/employees advising them that the business was found unsecure. There were two (2) Victim of Crime forms completed.

Community Service/Crime Prevention

(PROPERTY IDENTIFICATION PROGRAM)

During the month of May, police department personnel continued assisting rental agencies with tagging electronic equipment inside rental properties. The information will be entered into a database maintained by the department.

(NEIGHBORHOOD MEET & GREET PROGRAM)

Two (2) Meet & Greet meetings were held during this reporting period. The first meeting was held on May 9, 2013 from 5-6:00 p. m., on Forest Trail at 34th Avenue. There were approximately 15 citizens in attendance. The event was posted on the City website on 04/26/13, as the original meeting date (04/25/13) was cancelled due to inclement weather. Flyers were distributed by Officers on 05/01/13. The only issue of complaint received was traffic related. A citizen reported that the stop sign at the corner of 34th Avenue and Forest Trail is continuously disregarded. Captain Usry advised that she would schedule selected traffic enforcement for that area.

The second meeting was held on May 16, 2013 from 5-6:00 p. m. at Morgan's Cove Drive and Yacht Harbor Court. There were approximately 14 citizens in attendance. The event was posted on the City website and flyers were distributed throughout the neighborhood beginning 05/08/13 by patrol. There were a number of complaints regarding speeding and people disregarding the stop sign at Yacht Harbor Court and Morgan's Cove Drive. There were also a lot of complaints about bikes and golf carts in the area, as well as along Palm Boulevard. The attendees stated that juveniles are always driving golf carts around and the golfers aren't stopping at the stop signs at the golf cart crossing, posing a traffic hazard. The president of the Homeowners Association (HOA), Diane MULLINS, specifically ask for an Officer to run traffic on Morgan's Cove Drive at the curve during afternoon and early evening hours, and the stop sign between 0700-0730 hrs and 1700-1730 hrs.




