Isle of Palms Fire Department Call Summary February 2014

- 2/1/14 Personnel responded to a report of a motor vehicle accident with a possible rollover. Upon arrival personnel found a single vehicle accident with the patient outside the vehicle and a fire hydrant that had been sheared at its base. Water was coming out of the ground and the water department was notified. Charleston County EMS arrived on scene within minutes and patient care was transferred to them. After the water department personnel secured the water, fire department personnel removed as much of the debris as possible, but the road remained closed until the water department could make the necessary repairs. All units returned to service.
- 2/15/14 Personnel responded to a mutual aid request from the Awendaw Fire Department for a motor vehicle accident with a vehicle under water off U.S. Highway 17 North. The Isle of Palms Fire Department was asked to respond with an inflatable watercraft due to the size of the body of water. Upon arrival the watercraft was placed in the water and proceeded to the area of the vehicle. Personnel stood by while divers accessed the vehicle. They continued to stand by in area until the vehicle was removed from the water by crane. Once that was done all units returned to service.
- 2/20/14 Engine 1001 was requested to standby at Awendaw Fire Station No. 2 while their units were on an incident. After a short time, Engine 1001 returned to the Isle of Palms. The unit did not respond to any incidents while on standby.

All career personnel participated in personal protective equipment, firefighter rescue, water supply, and hose operations training.

Medical in-service training covered annual CPR refresher training.

Battalion Chiefs Bob Maibach and Jason Smith, and Captains Roger Eagle and James Giddens successfully completed the 3-day National Fire Academy course "Politics and The White Helmet" held at the Isle of Palms Public Safety Building. This course was held in conjunction with the S.C. Fire Academy.

Captain Roger Eagle; Engineers Seth Bacon, Dana Burnette, David Mello, David Micalizzi, Chris Puckhaber, and Trevor Speelman; and Firefighters Ken Carroll and Joey Teague, completed the 8-day Merchant Mariner training class. The program is U.S. Coast Guard sanctioned and was held at the Isle of Palms Public Safety Building.


