Date: AUGUST 5, 2008

The following is a synopsis of the activities of the Isle of Palms Police Department during the month of July 2008.

Patrol

July 1, 2008

Just after midnight, while conducting patrol on the Isle of Palms Connector, an officer observed a vehicle, traveling eastbound, being operated with, what appeared to be, wanton disregard. More specifically, the vehicle traveled into both the emergency lane and center median. The reporting officer conducted a traffic stop upon the vehicle and in speaking with the driver, detected a strong smell of alcoholic beverage emitting from within the vehicle, as well as from the person of the operator/driver. The driver voluntarily submitted to Field Sobriety Tests, which he was unable to successfully complete, confirming that his faculties to operate the motor vehicle were materially and appreciably impaired. The driver was detained and transported to the police department to be allowed an opportunity to submit to a Datamaster Test. The driver refused to provide a breath sample and was, subsequently, charged with DUI and transported to the Charleston County Detention Center for booking.

July 3, 2008

Officers responded to a residence on Palm Boulevard to investigate a noise complaint. Upon arrival, officers observed a group of approximately ten subjects in the garage area, underneath the house, playing what appeared to be "beer pong". The majority of the subjects appeared to be under the legal age of consumption and possession. Officers positively identified all subjects, thereby, confirming that five of the subjects were under twenty-one years of age (one being a juvenile). All five subjects were charged with Underage Possession of Alcohol. The adult host, who was also present, was charged

with Transfer of Beer to Minors. The juvenile was released to the custody of a legal guardian, and his charges will be presented in Family Court.

July 4, 2008

After more than twenty larcenies on the beach the previous month, a male and female suspect were arrested and initially charged with two thefts that they had just committed. Investigators had previously determined that a male and female subject, in a small white pickup truck, were using credit cards stolen on the beach to make fraudulent purchases in Mount Pleasant. Surveillance tape photos of the suspects and their vehicle were distributed to police personnel resulting in the vehicle being located entering a beach parking area. Subsequent to their arrest, a search of their vehicle resulted in the seizure of a significant amount of stolen property. Investigators received confessions, through interrogations of both subjects, of their involvement in at least ten similar, yet unrelated, cases yielding fifty-seven additional charges including Breaking and Entering Into a Motor Vehicle, Grand Larceny, Petit Larceny and Financial Transaction Card Theft and Financial Transaction Card Fraud.

July 5, 2008

An officer conducting foot patrol, of the front beach business district, was approached by an employee of a local bar. The employee reported that a male subject, who had been denied entry into the establishment, became enraged and threw a beer bottle at the front door, causing significant damage. The subject was located and, after a short foot pursuit, was taken into custody. The subject was subsequently charged with Disorderly Conduct and Resisting Arrest.

July 6, 2008

At approximately 1:30 A.M., officers responded to the beach in the area of the Sea Cabins pier, in reference to a fight in progress. Upon arrival, officers located two male subjects lying in the sand with apparent and significant manifestations of injury. Both victims sustained multiple lacerations to their head, and facial regions during the physical altercation. Witnesses advised responding officers that the two male assailants had fled the scene just prior to the arrival of officers. Officers conducted a search for the suspects with negative results. Isle of Palms Fire Department First Responders arrived on scene, conducted a rapid trauma assessment and collected baseline vitals of two victims. Charleston County EMS arrived on scene, shortly thereafter, and transported both victims to MUSC for further trauma assessment and treatment.

July 8, 2008

Officers were dispatched to a rental property on Palmetto Drive in reference to a possible fire. Upon arrival, officers observed the smell of smoke emitting from within the residence. A search of the unit produced an identification and location of origin as smoldering bed linens that had been placed in a closet in close proximity to a bare light bulb.

July 11, 2008

Police and Fire Department personnel responded to the beach in the 3000 block of Palm Blvd. in reference to a shark bite. Victim stated that he had been bitten on his right arm by a small shark. Charleston County EMS transported the subject to MUSC for further assessment and treatment. The beach from Ocean Point to Breach Inlet was closed to swimming until it was determined safe for re-entry.

July 14, 2008

Just before 1 A.M., an officer observed two male subjects sitting in a pickup truck parked in a parking space in the front beach business district. The officer stopped to investigate the suspicious activity and, while speaking to the subjects, observed what appeared to be marijuana on the floor of the vehicle. The owner of the vehicle was taken into custody and charged with Simple Possession of Marijuana.

July 15, 2008

While patrolling the Wild Dunes Community and on Palmetto Drive, an officer observed a vehicle maneuver in an erratic manner several times. A traffic stop was conducted. While speaking with the driver, the officer detected a strong smell of alcoholic beverage from within the vehicle, as well as from the driver's person. The driver submitted to several Field Sobriety tests, which she could not complete successfully. The driver provided a breath sample during a datamaster which indicated a blood alcohol level of .14% and was subsequently charged with DUI.

July 17, 2008

Isle of Palms police officers accompanied officers from Mount Pleasant and agents of the US Marshall's Service to a Charleston Boulevard residence with outstanding Arrest Warrants for a male suspect. The suspect was located hiding in a closet. Subject was taken into custody without incident.

July 18, 2008

At approximately 10:30 P.M., an officer conducting foot patrol on the front beach observed a vehicle fail to yield to pedestrians on Ocean Boulevard and thereafter, commit several additional moving violations. A traffic stop was conducted and, while speaking with the driver, the officer immediately detected a strong smell of alcoholic beverage from within the vehicle. The driver submitted to several Field Sobriety Tests, which she could not successfully complete. While being placed into handcuffs, the driver pulled away several times to avoid being restrained and passively resisted being taken into custody. Arrangements were made for her spouse to respond from Mount Pleasant to assume custody of their five year old child who had been in the vehicle at the time of the incident. The driver was transported to headquarters where she refused to provide a breath sample or to sign required documentation. She was charged with DUI, Child Endangerment, and Resisting Arrest.

July 22, 2008

While on patrol, an officer observed a vehicle disregard a stop sign then weave within the lane of travel, almost leaving the roadway. Upon conducting a traffic stop and speaking with the driver, the officer detected a strong smell of alcoholic beverage emitting from within the vehicle. The driver submitted to several Field Sobriety Tests, which he failed. The driver was then transported to headquarters to be administered a Datamaster Test, where he registered a .21% level of alcohol. The driver was charged with DUI and transported to the Detention Center.

July 21, 2008

Investigators arrested and served seventeen Arrest Warrants on one of the male subjects responsible for fourteen residential burglaries in May and June. He was charged with seven counts of Burglary 1st degree, two counts of Burglary 2nd degree, seven counts of Grand Larceny, and 1 count of Grand Larceny of a Motor Vehicle. The second subject identified and implicated was also arrested for similar outstanding warrants for his involvement. Investigators worked in closely with Mount Pleasant Police Department Investigators and several other police jurisdictions involving over fifty burglaries in Charleston and Berkeley Counties.

July 22, 2008

Through a narcotics investigation, a Search Warrant was obtained and executed at a Forest Trail residence, where it was suspected that a male subject living at the residence was manufacturing marijuana by cultivating at least fifty plants. The same subject was also suspect in the sale of Schedule II and IV Controlled Narcotics. The male and female occupants of the residence were arrested. The female was charged with Simple Possession of Marijuana. Her male counterpart was charged with Possession of Marijuana for Distribution, Possession of Marijuana for Distribution Within ½ Mile Proximity of a School or Playground, Manufacturing Marijuana, and Manufacturing Marijuana Within ½ Mile Proximity of a School or Playground.

July 23, 2008

An officer responded to a hotel in Wild Dunes where a 2008 BMW X5 had been reported stolen. The vehicle was one of three used as courtesy vehicles, provided by Southern Region BMW for the use of resort guests. The vehicle was valued at \$45,000.

July 23, 2008

Just after 2:30 A.M., an officer on patrol stopped a vehicle for an equipment violation, and while speaking to the occupants of the vehicle, information was obtained regarding an Outstanding Warrant for one of the occupants. The active warrant was out of the Charleston County Sheriff's Office for a Violation of Check Law charge. The subject was taken into custody and transferred to a Charleston County Deputy for transport.

July 23, 2008

After an officer stopped a vehicle for speeding on Palm Boulevard, the driver was determined to have an Active Arrest Warrant out of the Goose Creek Police Department for Failure to Appear For Court. The driver was taken into custody and released to a Goose Creek police officer for transport and booking.

July 23, 2008

Officers responded to a front beach condominium unit regarding a 911 hang-up. Upon arrival, officers determined that a male juvenile had deliberately cut his hand and was still in possession of a knife. The subject's grandmother had dialed 911 to report that her grandson had been out of control after being confronted about possible drug use. An officer was able to remove the knife from the juvenile's possession, and he was transported by EMS for evaluation. The officers seized drug paraphernalia that was present in the unit.

July 25, 2008

Officers responded to a residence on 23rd Avenue where a domestic dispute between two teenage sisters had been reported. Upon the officer's arrival, they determined that there was no sign of visible injury. The officers separated the sisters for the evening and no other action was necessary.

July 25, 2008

Officers accompanied a Mount Pleasant police officer to a residence on 31st Avenue to assist in the service of an Arrest Warrant for Criminal Domestic Violence. The male suspect was located, identified, arrested and turned over to the Mount Pleasant officer without further incident.

July 26, 2008

Just after 1:30 A.M., officers responded to a residence on 42nd Avenue to investigate a reported assault. The officers spoke to several witnesses present and determined that neither party wished to pursue charges; friends agreed to keep the two parties separated for the rest of the night.

July 27, 2008

An officer responded to the Charleston County Detention Center to serve an outstanding Arrest Warrant on a subject arrested by another police jurisdiction. The officer served the Isle of Palms Arrest Warrant on the subject for Defrauding an Innkeeper.

July 27, 2008

Just before 1 A.M., an officer on patrol observed a golf cart occupied by two male subjects operating in Wild Dunes near Sandcrab Court. The officer stopped the vehicle and observed that both teenage occupants were in possession of alcohol. One subject was charged with Minor in Possession of Beer and the other with Minor in Possession of Liquor.

July 27, 2008

At approximately 2:30 A.M., an officer on patrol stopped a vehicle on Ocean Boulevard for an equipment violation then discovered that the driver was wanted by the Dorchester County Sheriff's Office for a fraudulent check charge. The driver was taken into custody and transferred to a Dorchester County Deputy Sheriff.

July 27, 2008

After stopping a vehicle on 41st Avenue for speeding, the officer made the determination that the driver had a suspended license. Located in the floorboard of the vehicle was a quantity of marijuana. After being taken into custody, three counterfeit \$50 bills and one \$100 was located in the driver's wallet so the US Secret Service was immediately notified. The driver was transported to the Detention Center charged with Speeding, Simple Possession of Marijuana, DUS, and Unsafe Equipment. The counterfeit bills were turned over to a Secret Service Agent who met the officer at the Detention Center. The Secret Service will charge the subject for possession of the counterfeit currency.

July 27, 2008

An officer on patrol observed a male subject lying in the grass near Ocean Boulevard and JC Long Boulevard and stopped to investigate. The subject was determined to be extremely intoxicated; unable to tell the officer how to locate a friend or relative and was unable to care for himself. He was taken into custody and charged with Public Intoxication

July 31, 2008

An officer stopped to assist a Berkeley County Sheriff's Deputy in Mount Pleasant, near Clements Ferry Road, where an Armed Robbery suspect had fled into the woods. The officer assisted in setting up a perimeter, which resulted in the suspect being located by a K-9. The weapon used in the robbery was also recovered.

Personnel/Community Relations

July 3, 2008 PFC Ambas and PFC Thompson taught a bicycle safety class to three separate age groups of children at the Isle of Palms Recreation Center.

July 4, 2008 All available officers worked to provide security and traffic control for the annual July 4th Fireworks Display on the front beach.

July 19, 2008 BSOs Neal Johnson and Will Bailey received a letter of appreciation from a citizen who had recently visited the Isle of Palms to thank them for assisting the family in getting their elderly mother out onto the beach with a four- wheel drive vehicle.

July 23, 2008 The Isle of Palms Police Department manned several displays at the annual Disaster Preparedness Expo held this year at the Sullivan's Island Fire Department. The annual event is designed to educate people about evacuation in the event of a major storm or hurricane.

July 31, 2008 For the month of July, officers on patrol discovered three business and two homes with open or unsecured doors. A total of one hundred forty-five Victim of Crime Forms were issued to business or property owners for various violations noted by officers on patrol, or to advise that their business had been checked during the night.

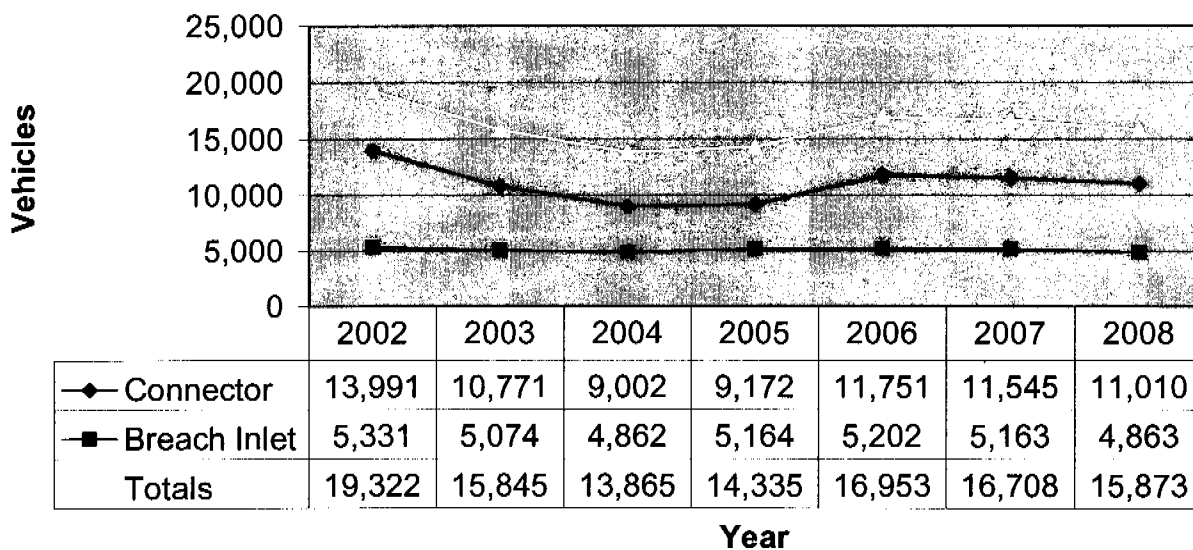
