Date: JULY 6, 2009

The following is a synopsis of some of the activities of the Isle of Palms Police Department during the month of June 2009.

Patrol

June 1, 2009 A Sullivan's Island police officer requested the assistance of an Isle of Palms officer to clear a home on Central Avenue that was discovered to have an unsecured door. The house was cleared and the officer returned a short time later.

June 3, 2009 A resident of Seagrass Lane reported that her boat, which was stored on a dock lift had been stolen during the night. The boat was located several hours later adrift near Ocean Point and Deewee's Island. The boat was recovered with slight damage to the motor.

June 4, 2009 At approximately 8:45 P.M., an officer responded to a citizens report that there were boaters in distress in the marsh on the Mount Pleasant side of the Connector. The officer made verbal contact with the subjects who confirmed that their boat was stuck in the marsh. The Isle of Palms Fire Department responded, but was unable to retrieve the subjects by boat. The Charleston County Rescue Department then responded with an airboat and retrieved the three boaters safely.

June 6, 2009 Just after midnight an officer on patrol encountered several young female subjects standing near several illegally parked vehicles in front of a residence on Ocean Boulevard. As the officer approached, two subjects walked away carrying bottled beer. When the officer determined that they were underage to drink, he then determined that a party was in progress at the residence. While speaking to the two subjects with the beer, he determined that both had provided incorrect information as to their identity. Both were

charged with False Information to the Police, and one with Minor in Possession of Alcohol. The person responsible for renting the home was located and charged with Exceeding the Maximum Allowed Vehicles, which was six. There were sixteen vehicles present.

June 6, 2009 An officer responded to the Marina Market area, where the theft of a dog had been reported. The officer determined that the dog was stolen from the Marina Store on May 31st, and returned this date. A suspect was identified and provided a statement, which was turned over to an Investigator, who ended up charging two suspects with Petit Larceny.

June 7, 2009 An officer on patrol of the beach near 41st Avenue observed three young male subjects consuming beer on the beach. After the subject being taken into custody, a quantity of marijuana was confiscated. The three sixteen year olds were charged with Minor in Possession of Beer and Simple Possession of Marijuana. Since all are juveniles the case will be heard in Family Court.

June 8, 2009 A resident of Carolina Boulevard reported that he had been threatened by his next door neighbor, by stating that he was going to assault him and vandalize his pickup truck. He stated that the suspect made additional specific threats that placed him in fear for his safety. This case has been assigned to an Investigator.

June 10, 2009 Officers responded to Conch Court in Wild Dunes, where a possible break-in in progress had been reported. A neighbor observed the suspect attempting to steal a 4WD ATV from a nearby garage, along with several other household items, and observed the suspect, who is known by the victim's neighbor. The suspect managed to load the items onto the ATV and leave the garage, but had difficulty keeping the vehicle running. The first officer that arrived immediately detained the suspect, and subsequent investigation determined that the suspect had parked a pickup truck on 49th Avenue then entered Wild Dunes by a nearby beach access path. The vehicle was located and determined to have been reported missing on June 6th in Florence County. Of the \$6,700 worth of property stolen, all was recovered. The suspect was charged with Burglary 2nd degree, and Grand Larceny of a Motor Vehicle.

June 11, 2009 Officers responded to a Seagrove Lane residence where an assault had been reported. An officer met the alleged victim, who stated that a male subject inside of the residence had assaulted him in the face. The officers determined that the altercation took place over moving furniture to accommodate an aero bed. All three subjects present had consumed a large quantity of beer, which clouded their reasoning. The victim was transported to a local hotel for the evening.

June 11, 2009 At approximately 9 A.M., officers responded to the beach near 2nd Avenue, where citizens had reported a male subject swimming and making rude comments to beachgoers walking by. The citizens also reported that the subject might be intoxicated since he was observed consuming quantities of beer while on the beach. The subject was located and determined to be in possession of beer as well as being

intoxicated. The subject was charged with Public Intoxication and No Alcohol on the Beach.

June 12, 2009 An officer on patrol encountered a vehicle stopped in the middle of the road on Palm Boulevard near 41st Avenue and observed someone to be asleep behind the steering wheel. After awakening the subject, it was apparent that he had been consuming alcohol. Since he was unable to get someone to respond to his location for a ride home the subject was taken into custody and charged with Public Intoxication.

June 13, 2009 A front beach business reported that they had a male juvenile in custody for shoplifting in the business. The officer assumed custody and made contact with the suspect's parent, who responded and assumed custody of their juvenile. The fifteen year old was charged with Shoplifting which will be handled in Family Court.

June 13, 2009 Officers responded to a front beach nightspot, where it was reported that a male subject had stolen the tip jar from the stage where musicians had been playing on the back deck of the business. After taking the jar the subject was observed by the complainant on the beach emptying the jar and was detained by him until police arrived. The responding officer immediately detected a strong odor of alcohol on the suspect while handcuffing him. The suspect still had the entire \$144 stolen in his possession, which was photographed and returned to the complainant. The suspect was charged with Public Intoxication and Petit Larceny then transported to the Detention Center.

June 14, 2009 An employee of the County Park reported a group of Hispanic males were going through the belongings of a group of people that were in the ocean. The employee gave a good description of the subjects, who were located south of the County Park. The officer encountered one male subject consuming what was identified as liquor from a yogurt container. That subject was taken into custody and charged with No Alcohol on the Beach and Disorderly Conduct. The owner of the belongings could not determine if anything had been stolen. The subject taken into custody was unable to provide proper identification and refused to give proper name to an interpreter. He was lodged in the County Detention Center as John Doe until his true identity was determined.

June 14, 2009 Several people on the beach near 25th Avenue reported a woman in her fifties harassing people on the beach by kicking sand and using loud profanity. An officer located the subject, who was observed staggering and almost falling down several times. Due to her extreme state of intoxication she was taken into custody and charged with Disorderly Conduct and No Alcohol on the Beach then transported to the Detention Center.

June 14, 2009 A front beach establishment reported that a male subject refused to leave their premises after he was asked to do so due to his intoxicated state. An officer escorted the subject from the establishment and while speaking to him outside the subjects demeanor changed and he became extremely agitated and while being taken into custody resisted by pulling away and avoiding being handcuffed. He was charged with Public Intoxication and Resisting Arrest.

June 15, 2009 While at a service call on 32nd Avenue a person advised the officer that he believed that a female subject currently staying in his residence had an outstanding Arrest Warrant. The officer checked the name in the computer and confirmed that she was wanted by the Richland County Sheriff's Office with statewide extradition. The female subject was positively identified taken into custody and transported to the Detention Center.

June 16, 2009 The manager of the Charleston County Park reported seeing an alligator swimming in the surf near the park. Officers responded and closed that portion of the beach to swimmers and kept a visual on the alligator until Department of Natural Resources personnel responded and safely removed the 8 foot gator from the surf.

June 16, 2009 A Beach Services Officer reported a male subject passed out on the beach near Ocean Point. Since he had been unable to awaken the subject he summoned a police officer to respond, who determined that the subject might need medical attention. First Responders treated the subject, who was also attended to by EMS. Due to the subjects intoxicated state he was taken into custody, charged with Public Intoxication and No Alcohol on Beach.

June 18, 2009 Just after midnight, officers responded to a front beach hotel where a domestic dispute had been reported. The officers determined that the situation was verbal in nature and both parties agreed to refrain from arguing for the rest of the evening.

June 19, 2009 Just after 2 A.M., an officer observed a vehicle occupied by five male subjects then observed the driver discard papers out of the window to the ground. While investigating, the officer determined that all five subjects had been consuming alcohol on the beach just prior to this encounter. A bag of marijuana was located in the vehicle causing all to be charged with Simple Possession of Marijuana. Three of the occupants were juveniles and released to the custody of a parent. The driver had the additional charged of DUS, NRVC 2 counts for unpaid traffic Tickets, and Littering.

June 19, 2009 Officers responded to Grand Pavilion in Wild Dunes where a husband reported that his wife might have attempted to commit suicide. He told the responding officer that she had been drinking alcohol and ingested prescription medication then left her husband and child in their room while she went to a nearby pool and fell in. She later made comments, which would indicate she wanted to end her life. She was located and agreed to be transported by EMS to a local hospital for evaluation.

June 19, 2009 Officers responded to a residence on Charleston Boulevard where loud music being played had been reported. The responding officer could hear music playing and people talking and laughing. When officers approached the residence to speak to the occupants they encountered five or six subjects on the back deck consuming alcohol. Two subjects present were determined to be underage and were each charged with Minor in Possession of Alcohol. The group was advised about the noise ordinance.

June 20, 2009 Just after 2 A.M., an officer on patrol encountered a male subject on the ground on Palm Boulevard near 20th Avenue and stopped to investigate. The officer made several attempts to awaken the subject, which he did and attempted to get the subject to call a friend for a ride home. Since he was unable to do so he was taken into custody and charged with Public Intoxication.

June 20, 2009 A citizen reported a reckless driver in an SUV on Palm Boulevard near 54th Avenue and a nearby officer encountered the vehicle after observing it make several abrupt turns from 52nd and then again on 51st Avenue. Once the vehicle was stopped it was determined that both occupants were in possession of beer. The driver, who was over twenty-one was charged with Transfer of Beer/Wine to a Minor and Open Container, and the passenger with Underage Possession of Alcohol and Open Container.

June 22, 2009 An officer on patrol on the Connector clocked a vehicle traveling in the opposite direction, inbound to the Isle of Palms, doing 112 miles per hour. The officer turned on the violator and stopped the vehicle on Palm Boulevard near 21st Avenue. While speaking to the driver, the officer detected a strong odor of alcohol from within the vehicle. The driver admitted that he had been drinking beer and submitted to several Field Sobriety Tests. He was then transported to headquarters and submitted to a Datamaster Test where he registered a .17% level of alcohol and was charged with DUI.

June 22, 2009 A female subject came to police headquarters to report that a housemate sexually assaulted her when she returned home earlier that morning. An Investigator responded and obtained a sworn statement then located the suspect, who also provided a sworn statement. The suspect was taken into custody and charged with Simple Assault.

June 23, 2009 The police department received a Family Court Bench Warrant from the Charleston County Sheriff's Office Warrant Division, which was forwarded from Horry County for a resident of the Isle of Palms. Contact was made with a family member, who arranged for the subject to turn himself in. When the subject came to headquarters he was taken into custody and transferred to the Detention Center on hold for Horry County to respond and assume custody.

June 23, 2009 An officer stopped a vehicle on Palm Boulevard near 50th Avenue after disregarding a stop sign. After making contact with the driver it was determined that the driver was wanted by the Berkeley County Sheriff's Office for Simple Assault and from a police agency in Florida for Grand larceny of a Vehicle. The driver was detained for the outstanding arrest warrants then found to be in possession of a quantity of marijuana. He was charged with Simple Possession of Marijuana and transported to the Detention Center to await extradition.

June 25, 2009 Officers responded to a front beach business where management reported that two females had shoplifted bathing suits from the store. An employee who was following the suspects directed officers to their location. Both stolen swimsuits were recovered and both subjects, who were identified as juveniles were charged with

Shoplifting. Due to the fact that both they were juveniles their case will be prosecuted in Family Court.

June 27, 2009 Officers responded to a residence on Hartnett Boulevard that had been reportedly struck by lightning. The officers observed fresh damage to the corner of the exterior roof and a strong odor of smoke. The officers evacuated the residents and three dogs from the residence prior to the arrival of fire department personnel.

June 27, 2009 An officer responded to the 5th Avenue Beach Access where a vehicle was reported to be stuck in the sand. The officer located the vehicle, which was stuck in the sand, requiring it to be towed from the area. The driver was charged with Driving a Vehicle on the Beach.

June 27, 2009 An officer responded to the parking lot of a Palm Boulevard gas station where a citizen reported that someone had backed their SUV into her vehicle while she was pumping gas, then drove away. The victim was able to provide the license plate number and a description of the driver, which allowed the officer to locate the vehicle and driver at her residence in Wild Dunes. The driver was charged with Improper Backing and Leaving the Scene of an Accident with Property Damage.

June 27, 2009 Just before midnight an officer on patrol observed a golf cart operating on Pavilion Drive and stopped to investigate. While the officer was speaking to the driver he detected a strong odor of alcohol and observed that he had an open container of alcohol. He was charged with Operating a Golf Cart After Dark and Public Intoxication.

June 29, 2009 Officers responded to a domestic dispute at a Sandcrab Court residence, which turned out to be a custody dispute over visitation rights. The matter was resolved for the evening after a female child was allowed to leave the residence with her mother.

June 29, 2009 Management of the Charleston County Park & Recreation Commission requested that an officer be present in their office while they terminated an employee. After being terminated, it was discovered that the subject had two unpaid tickets on his driver's license. He was charged with NRVC 2 counts and transported to the Detention Center.

Personnel/Community Relations

June 1, 2009 PFC Chavez and Ptl. McElroy received a letter of appreciation from a grateful citizen whom they recently assisted on the side of the road.

June 2, 2009 A resident of Wild Dunes submitted a letter of appreciation to Sgt. J. Ryan, Sgt. D. Ambrosio, PFC J. Stanko, and Ptl. McElroy for their recent actions in locating and arresting the subject responsible for colliding with her parked vehicle then leaving the scene.

June 16, 2009 Sgt. Jimenez and Ptl. Funsch received a letter of appreciation from the staff at MUSC for assisting with the Annual ALS Hope 5K Run/Walk.

June 17, 2009 PFC Hicks received a letter of appreciation for a warning she received rather than a speeding ticket.

June 17, 2009 PFC Baldrick and Ptl. Funsch received a letter of appreciation from a citizen that they assisted.

June 30, 2009 For the month of June, officers discovered two businesses and three homes with open or unsecured doors. A total of fourteen Victim of Crime Forms were issued to business or property owners for various violations noted, or to advise them that an officer checked their location during the night while on patrol.
