The following is a synopsis of some of the activities of the Isle of Palms Police Department during the month of November.

#### Sunday, November 4

#### Open Container - 31A Public Beach Access

At approximately 1:16am an officer observed a vehicle illegally parked in front of the beach access path with the occupants inside. During the investigation it was determined that the smell of marijuana was emitting from inside the vehicle. The occupants admitted to smoking all the marijuana they had, but still had the smoking device. The officer found the passenger to be in possession of an open container of beer. The subjects were charged with unlawful possession of drug paraphernalia and open container with a court date in the Isle of Palms Municipal Court.

#### Telephone Calls/Obscene/Harassing – 400 Block Carolina Boulevard

A victim reported that an unknown subject began sending her text messages indicating that they were watching her from outside her residence. This case was assigned to CID for further investigation and it was determined that this was a random incident and that the number used to send the text messages was involved with multiple prank text incidents. Officers checked the victim's residence to make sure everything was secure. Should anything else evolve from this incident CID will continue their investigation.

#### Tuesday, November 6

#### Driving Under the Influence – 38th Avenue / Palm Boulevard

At approximately 9:39am, an officer stopped a vehicle for multiple moving violations. Upon contact with the driver, it was determined that she was possibly under the influence. The officer checked the driver's license and determined that her South Carolina Driver's License was suspended for driving with an unlawful alcohol concentration. The officer asked the officer to perform Standardized Field Sobriety Tests and upon completion was placed under arrest for driving under the influence. The driver was transported for Datamaster testing where she provided a breath sample with a blood alcohol concentration of .076%. The driver was lodged in the Al Cannon Detention Center.

#### Wednesday, November 7

#### Impersonation - 23rd Avenue

A victim reported that his bank accounts had been compromised when he was checking his accounts online. The victim contacted his bank and determined that an unknown subject went into three different banks and took money from his account in the total of \$5,550. This case has been assigned to CID for further investigation.

#### **Thursday, November 8**

#### Simple Possession of Marijuana - IOP Connector

An officer stopped a vehicle for speeding, 86MPH in a posted 55MPH speed zone. While speaking with the driver, the officer noticed a strong odor of marijuana emitting from within the vehicle. An open bottle of vodka was also observed on the rear floorboard. The driver was charged with speeding, simple possession of marijuana and unlawful possession of liquor with broken seal with a court date in the Charleston County Magistrate Court.

#### Friday, November 9

#### <u>Driving Under the Influence</u> – 2<sup>nd</sup> Avenue / Carolina Boulevard

An officer stopped a vehicle for multiple moving violations. While speaking with the driver the officer determined that she was possibly under the influence. The officer requested that the driver complete Standardized Field Sobriety Tests and upon completion was placed under arrest. The driver was transported to complete Datamaster testing where she refused to provide a breath sample. The driver was lodged in the Al Cannon Detention Center.

#### <u>Driving Under Suspension</u> – 14th Avenue / Palm Boulevard

An officer stopped a vehicle for an equipment violation. A check of the driver's license determined that his driver's license was suspended for no proof of insurance. The driver was issued citations for DUS 1<sup>st</sup> and possession of a suspended vehicle license plate with a court date in the Isle of Palms Municipal Court.

#### Saturday, November 10

#### <u>Destruction/Damage/Vandalism of Property</u> – Ensign Court

A victim reported that a known subject entered his residence and purposefully cut the wires to his computer and the cables to the speakers. The approximate value of the damage is \$100. This case has been assigned to CID for further investigation.

#### Sunday, November 11

#### Telephone Calls/Obscene/Harassing - 1100 Block Ocean Boulevard

A victim reported that she was receiving harassing text messages from an employee's boyfriend who had completed some floor work at her home. The initial text message was related to the subject leaving tools at the victim's home, but there were none located. The subject continued sending harassing text messages. The victim reported that the subject came to the business to pick up his girlfriend and made threats towards the business, stating "I've got two thirty round clips" and then left. This case was assigned to CID for further investigation.

#### Burglary - 2300 Block Waterway Boulevard

A victim reported that while he was out of town he could see two subjects on his security camera system outside his residence. The victim indicated that the subjects were near his garage, then went into the backyard and were attempting to enter his home. Officers responded but there were no persons on scene upon their arrival and there was no sign of entry into the residence. This case has been assigned to CID for further investigation.

#### Tuesday, November 13

#### Credit Card Fraud/ATM - 43rd Avenue

A victim reported that there had been unauthorized charges to her credit card in the amount of \$1,443. Notification was made to the credit card company and the account was closed. This case has been assigned to CID for further investigation.

#### Thursday, November 15

#### Theft from Motor Vehicle - 22<sup>nd</sup> Avenue

A victim reported that on October 22 his vehicle had been parked in front of his home and that unknown persons entered the unlocked vehicle and stole \$4,600 that had been left in the center console. The victim indicated he had a security camera near his front door and could see headlights from a vehicle as it pulled away. The victim deleted the security camera video footage. This case has been assigned to CID for further investigation.

#### Stolen Property Offenses - 41st Avenue

A victim reported that an unknown subject stole a marine battery from his boat that was docked in Mount Pleasant and he was able to locate the item on a boat docked at the IOP Marina. The victim indicated that the battery had a label with his name on it from where it had been tested at a local auto parts store. A search warrant was obtained, and the battery was located on the docked boat. This case has been assigned to CID for further investigation.

#### Monday, November 19

#### **Burglary** - Fairway Oaks Lane

A property manager reported that a door on a residence she manages appears to have been pried open. Officers checked the residence but did not find anyone inside or anything that appeared to be out of place. This case has been assigned to CID for further investigation.

#### False Pretense/Swindle/Confidence Game - 100 Block Charleston Boulevard

A victim reported that he had been in contact with a subject to rent a home during the week of Christmas and had transferred \$3,262 into an account as instructed. After making this transfer the victim discovered it was a rental scam and that the property was not owned by the person to whom he had transferred the money. This case has been assigned to CID for further investigation.

#### Tuesday, November 20

#### Driving Under the Influence - 10th Avenue / Palm Boulevard

On officer on patrol at 7:00am observed a vehicle pass by and then accelerated to 53MPH in a posted 35MPH speed zone. The officer conducted a traffic stop and upon contact with the driver determined that she was possibly under the influence. The officer asked the driver to perform Standardized Field Sobriety tests and upon completion was placed under arrest. The driver was transported for Datamaster testing where she refused to provide a breath sample. The driver was lodged in the Al Cannon Detention Center.

#### Sunday, November 25

#### Driving Under the Influence - 200 Block Forest Trail

Officers responded to a report of a single vehicle collision with a tree. Upon arrival, the vehicle was no longer on scene, but an officer observed the vehicle leaving the area and conducted a traffic stop. Contact with the driver determined that he was possibly under the influence. When asked if he had been drinking the driver indicated that he had a few drinks at home. When asked to perform Standardized Field Sobriety tests the driver refused and was placed under arrest. The driver was transported for Datamaster testing where he refused to provide a breath sample. The driver was lodged in the Al Cannon Detention Center.

#### Monday, November 26

#### <u>Traffic Offense</u> – Waterway Boulevard / 30th Avenue

An officer stopped a vehicle for speeding, 35MPH in a posted 25MPH speed zone. Contact with the driver determined that he did not possess a driver's license. The driver was issued a citation for no driver's license with a court date in the Isle of Palms Municipal Court.

#### Traffic Offense - 900 Block Palm Boulevard

An officer stopped a vehicle for speeding, 48MPH in a posted 35MPH speed zone. Contact with the driver determined that he did not possess a driver's license. The driver was issued a citation for no driver's license with a court date in the Isle of Palms Municipal Court.

#### Tuesday, November 27

#### Simple Possession of Marijuana - 300 Block Palm Boulevard

An officer stopped a vehicle for speeding, 47MPH in a posted 35MPH speed zone. While speaking with the driver the officer detected the odor of marijuana emitting from inside the vehicle. The driver admitted to having marijuana in his backpack, where the officer located it.

#### Wednesday, November 28

#### <u>Liquor Law Violations</u> – 1500 Block Palm Boulevard

An officer observed vehicle parked improperly in a parking space at 12:54am and when checking inside the vehicle located a male subject sleeping inside. The officer also saw in plain view an open bottle of liquor. The officer woke up the subject, who refused to cooperate and exit the vehicle. The subject indicated that he was living in his car and had recently been arrested for drug charges. The subject was

arrested for unlawful sleeping in a vehicle and unlawful possession of liquor with a broken seal and was transported to the Al Cannon Detention Center.

#### Driving Under the Influence - 1100 Block of Ocean Boulevard

Officers responded to a report of an intoxicated driver, finding the vehicle parked across two parking spots with the driver passed out behind the steering wheel, which was running and in neutral. The officer observed an open bottle of wine on the front passenger side floorboard with the cork laying on the seat. The officer determined that she was possibly under the influence and asked if she would complete Standardized Field Sobriety tests, which she refused. The driver was transported for Datamaster testing but refused to provide a breath sample. The driver was charged with DUI 2<sup>nd</sup> offense and open container and was lodged in the Al Cannon Detention Center.

#### Thursday, November 29

#### <u>Driving Under Suspension</u> – IOP Connector

An officer stopped a vehicle for speeding, 69MPH in a posted 55MPH speed zone. Contact with the driver determined that his driver's license was suspended for failure to appear for a traffic citation. The driver was issued a citation for DUS 2<sup>nd</sup> offense with a court date in the Charleston County Magistrate Court.

#### Friday, November 30

#### Simple Possession of Marijuana - IOP Connector

An officer stopped a vehicle for speeding 80MPH in a posted 55MPH speed zone. During contact with the driver the officer observed a strong odor of marijuana emitting from inside the vehicle. When asked the driver admitted to possessing marijuana and a baggie was located on the passenger side floorboard. The driver was issued citations for speeding and simple possession of marijuana with a court date in the Charleston County Magistrate Court.

#### **Community Service Activities / Notable Mentions**

During the month of November 2018, Officers issued forty-four (44) "Property Security Check Notices" and twelve (12) "You Could Have Been a Victim of a Crime" notices.

November 7 – Detective Louise Hardy, Detective Robert Forsythe, Sergeant Chad King, FTO James Couche and PFC Thomas Molino attended the Keenager's Luncheon. The assisted the attendees with bringing in food and setting up. They interacted with them, answering questions and socializing.

November 16 – Detective Sergeant Sharon Baldrick, Livability Sergeant Kraig Thompson, Sergeant Derrick Ambas, PFC Karina Garcia and PFC Stephanie Tucker participated in the Cops on Top of the Donut Shop at Krispy Kreme as a fund-raiser for Special Olympics. Officers from eight other law enforcement agencies and several media outlets also participated in this event organized by Mount Pleasant Police Department. Officers helped raise \$37,500 at the Cops on the Coop event in October at Chick-Fil-A and over \$10,000 at the Cops on Top of the Donut Shop event.
