The following is a synopsis of some of the activities of the Isle of Palms Police Department during the month of August.

Wednesday, August 2

<u>Liquor Law Violation</u> – 48th Avenue Public Beach Access

On officer on foot patrol on the beach observed a subject with plastic cups and a bottle of wine. The subject was advised of the violation and admitted that he should have known better. The subject was arrested and issued a citation.

Thursday, August 3

Vandalism of Property -1300 Block Ocean Boulevard

A victim reported that unknown person(s) shattered the passenger side window on their car. There was nothing taken from the vehicle. The estimated damage to the vehicle is \$200. This case was assigned to CID for further investigation.

Sunday, August 6

Narcotics Violation – 1500 Block Palm Boulevard

An officer stopped a vehicle for an equipment violation. While speaking with the driver, the officer observed a piece of a marijuana cigarette commonly called a "roach" sitting on the center console. When asked, both the driver and passenger admitted to have more marijuana in the vehicle. They were both placed under arrest. Further investigation found drug paraphernalia. The subjects were charged and released.

False Info to Police - 7th Avenue / Ocean Boulevard

An Animal Control Officer issued a citation to a subject for dog at large and it was determined that she gave false identity information. An officer responded to assist and upon locating the violator, attempted to confirm her identity. The violator insisted that she had given the correct name, but when the officer had her produce her driver's license, it was determined that she did provide false information. The violator was given an additional charge of providing false information to an officer.

Motor Vehicle Theft - Morgan's Cove Drive

A victim reported that unknown person(s) had stolen his golf cart which had been legally parked at the marina. The victim did not leave his keys in the cart. The approximate value of the stolen item is \$3,500. This case was assigned to CID for further investigation.

Tuesday, August 8

Traffic Stop / Warrant Arrest – IOP Connector

An officer lawfully stopped a vehicle for a traffic violation. Further investigation found that the driver had an outstanding arrest warrant with the SC Department of Corrections for violation of release for burglary, domestic violence and selling cocaine base. The driver was placed under arrest and transported to the Al Cannon Detention Center.

Grand Larceny – 2300 Block Cameron Boulevard

A victim reported that he was doing renovations at a residence and left his tools at the job site. When he returned, all the tools were missing. The approximate value of the stolen property is \$1,725. This case has been assigned to CID for further investigation.

Friday, August 11

Agency Assist - Beach / Behind Coconut Joe's

Officers responded to a report of a possible drowning. On their arrival, the located a male subject laying in the water and immediately started CPR until IOP Fire Department and Charleston County EMS arrived to take over medical care.

Burglary - 2900 Block Palm Boulevard

A property manager for a rental property reported that an unauthorized subject was staying inside the rental property. Officers located and identified a female subject who claimed she had rented the property through Craig's List, but was unable to provide a copy of a rental agreement, receipt for the money, or a key for the property. Further investigation discovered that forced entry was made through a bathroom window. The female subject was arrested and transported to the Al Cannon Detention Center.

Theft from Motor Vehicle - 1100 Block Pavilion Drive

A victim reported that unknown person(s) stole her wallet from inside her parked vehicle. Further investigation found that there was no forced entry into the vehicle. The approximate value of the items stolen is \$235. This case has been assigned to CID for further investigation.

Saturday, August 12

<u>Driving Under the Influence</u> – Ocean Boulevard / Pavilion Drive

An officer stopped a vehicle for driving with no headlights on at night. While speaking with the driver, the officer observed a strong odor of an alcoholic beverage and asked the driver how much she had to drink. The driver indicated that she had two beers earlier. The officer requested the driver to perform Standardized Field Sobriety Tests and after the tests, placed the driver under arrest. The driver was transported to the IOP Public Safety Building for Datamaster testing. The driver refused to provide a breath sample and was charged with DUI, open container and transported to the Al Cannon Detention Center.

Simple Assault – JC Long Boulevard

A victim reported the next day that while out drinking with friends, they got involved in a heated discussion and one of his friends punched him in the face, causing him to fall to the ground. This case has been assigned to CID for further investigation.

Theft from Buildings - 500 Block Ocean Boulevard

A victim reported that unknown person(s) had stolen several model airplanes from the owner's closet of his rental property. The approximate value of the items stolen is \$1,300. This case has been assigned to CID for further investigation.

Sunday, August 13

Disorderly Conduct - 800 Block Ocean Boulevard

An officer responded to a report of two missing persons on the beach. While patrolling for the subjects, their clothing was found lying on the beach. One of the subjects was located walking up the beach and when asked, was told the other subject was in the water and that they both had been drinking. Officers located the subject in the water and gave repeated commands to come out of the water. When the subject finally came up to the beach, he was found to be extremely intoxicated and uncooperative. He was placed under arrest and issued a citation.

Disorderly Conduct - 1100 Block Ocean Boulevard

An officer was flagged down by a citizen who explained that there was a male subject passed out on the beach behind and when they tried to wake him up, he would not respond. The officer located the subject, who was covered in sand with several beer bottles lying on the ground next to him. When the officer woke up the subject, who was grossly intoxicated, he stated he was with friends staying in Mount Pleasant. The officer escorted the subject back to the street, where he began yelling and being uncooperative. The subject was arrested and transported to the Al Cannon Detention Center.

Simple Possession of Marijuana - 1500 Block Palm Boulevard

An officer stopped a vehicle for an equipment violation. Further investigation found that the driver had a suspended driver's license and no insurance on the vehicle. The driver was arrested and during a pretow inventory search of the vehicle, the officer located a clear plastic baggie containing marijuana and drug paraphernalia. The driver was transported to the Al Cannon Detention Center.

Tuesday, August 15

Disorderly Conduct - 1000 Block Ocean Boulevard

An officer was flagged down by a citizen who advised that there was a female subject passed out on the grass next to the Windjammer. The officer located the female subject and upon waking her up, determined that she was grossly intoxicated. The subject was unable to provide any information on where she was staying or a phone number for someone to pick her up. The subject was placed under arrest and transported to the Al Cannon Detention Center.

Wednesday, August 16

Underage Possession of Alcohol - 1100 Block Pavilion Drive

An officer on patrol during night shift located a parked vehicle with several subjects drinking beer. The officer checked the identification of the subjects and determined that four out of the five subjects were under 21 years of age. The minors were arrested and issued citations.

Petit Larceny - 23rd Avenue / Palm Boulevard

A victim reported that while out on the beach, she went for a walk, leaving her beach bag next to her chair. Upon her return, she found that her iPhone had been stolen. The approximate value of the stolen item is \$600. This case has been assigned to CID for further investigation.

Theft from Buildings - 26th Avenue

A victim reported that unknown person(s) had stolen his watch from the bed stand when he left the house. He stated that the only persons that had been at the house were housekeeping staff. The approximate value of the stolen item is \$400. This case has been assigned to CID for further investigation.

Friday, August 18

False Pretense / Swindle / Confidence Game - 7600 Block Palmetto Drive

A victim reported that she had rented a vacation property through Craig's List and provided the information to the officer showing the payment receipt and Craig's List listing number. It was determined that the victim was given a false address that she paid \$1,300 to rent. This case has been assigned to CID for further investigation.

Motor Vehicle Theft - 41st Avenue

A victim reported that unknown person(s) stole her golf cart that had been legally parked. The owner was able to provide a serial number and the vehicle was entered into NCIC as stolen. The approximate value of the stolen item is \$3,500. This case has been assigned to CID for further investigation.

Saturday, August 19

Domestic Violence - 1300 Block Ocean Boulevard

Officers responded to a report of a domestic altercation and located the subjects involved. The officers separated the subjects and determined that the female subject had scratched the male subject on the face and drew blood. Additionally, the male subject had injuries to his arm and shoulder. The female subject admitted to causing the injuries, was arrested and transported to the Al Cannon Detention Center.

Aggravated Assault - 1200 Block Palm Boulevard

Officers responded to a report of a disturbance at a local convenience store. Officers met with the victim, who advised that the subject had left the area and provided a description. The victim advised that while inside the store, the subjects began to harass them while standing in line. When they walked outside to their car, the subjects continued to harass the victim, with one of the subjects stating "I got something for you", then reached inside the car, grabbed a black handgun and pointed it towards her vehicle. This case has been assigned to CID for further investigation.

Sunday, August 20

Disorderly Conduct - 1000 Block Ocean Boulevard

On officer on night shift patrol, observed a male subject standing between two cars urinating in public. The male subject was extremely intoxicated and explained that he had to use the restroom badly and could not wait. The subject was arrested and released to a sober driver.

Driving Under the Influence - Ocean Boulevard / J C Long Boulevard

An officer observed a large recreational vehicle parked in the middle of the road and made contact with the male subject in the driver's seat. The officer noticed a strong odor of an alcoholic beverage coming from the driver and noticed that the driver was having difficulty sitting up in the driver's seat. The driver refused to complete any of the Standardized Field Sobriety Tests and was placed under arrest. He was transported to the Al Cannon Detention Center for Datamaster testing, where he refused to provide a breath sample. The driver was lodged into the Detention Center.

Monday, August 21

Simple Possession of Marijuana - 21st Avenue / Palm Boulevard

An officer on night shift patrol observed a subject getting out of the back of an SUV that appeared to have a bed made in the back. The officer made contact with the subject and while speaking with him noticed a strong odor of marijuana emitting from inside the vehicle. When asked, the subject admitted to possessing the marijuana and handed the container to the officer. The subject was arrested and issued citations.

Theft from Motor Vehicle – 100 Block Palm Boulevard

A victim reported that unknown person(s) broke the passenger side window of her vehicle and stole her purse. The approximate value of the items stolen is \$550 and the damage to the vehicle is estimated at \$1,000. This case has been assigned to CID for further investigation.

Vandalism - 6th Avenue / Carolina Boulevard

An officer on patrol was flagged down by a citizen about a male subject who had pulled a traffic direction sign out of the ground and threw it down. Upon making contact with the subject, he explained that he was angry because he had been issued a parking ticket. The officer arrested the subject and issued a citation for damaging signs.

Friday, August 25

Possession of False Driver's License – Waterway Boulevard / Shady Lane

An officer stopped a vehicle for a moving violation and when asked, the driver was unable to provide a driver's license. During further investigation, the officer recognized the female passenger who had been arrested earlier in the month for burglary of a rental property. When asked for identification, the female passenger gave the officer a fake driver's license. Both subjects were placed under arrest and transported to the Al Cannon Detention Center. A pre-tow inventory of the vehicle found several electronic devices, cell phones, debit cards and other items that are possible stolen. This case has been assigned to CID for further investigation.

Saturday, August 26

Disorderly Conduct - 5800 Block Palmetto Drive

Officers responded to a report of a male subject causing a disturbance with the Wild Dunes Resort employees and yelling while outside the building, waking up guests. Officers located the subject, who was sitting at a table with an open beer and had a closed fist with a metal object in his hand. The officer instructed him to drop the item, open his hand and he was under arrest. The subject attempted to run from the officer, but was apprehended without incident. It was determined that the subject was also under the age of 21. He was arrested and issued citations.

Theft from Motor Vehicle - 7600 Palmetto Drive

A victim reported that unknown person(s) stole her wallet from inside her vehicle, which she was unable to remember if it had been locked. The approximate value of the stolen items is \$430. This case has been assigned to CID for further investigation.

Sunday, August 27

Burglary - Seashell Lane

A victim reported that unknown person(s) entered the rental property and saw that two televisions had been stolen. The approximate value of the stolen items is \$700. This case has been assigned to CID for further investigation.

Warrant Arrest - IOP Connector/ Palm Boulevard

An officer stopped a vehicle for an equipment violation. Further investigation found that the driver had an active arrest warrant with Charleston County Sheriff's Office for leaving the scene of a hit and run collision. The driver was arrested and transferred to the Charleston County Sheriff's Office.

Command Staff recognizes the following personnel:

Sergeant Jamey Meekins and Ptl. Stephanie Tucker for their immediate response to a possible drowning, locating the subject in the water and immediately starting life-saving efforts until relieved by IOP Fire Department First Responders and Charleston County EMS.

Community Service <u>Activities</u>

During the month of August 2017, Officers issued two hundred forty two (242) "Property Security Check Notices" and fifty two (52) "You Could Have Been a Victim of a Crime" notices.

August 1 – FTO Louise Hardy coordinated the 3rd Annual National Night Out event at the Isle of Palms Recreation Department, with approximately 250 – 275 citizens in attendance. A jump castle, face painter, bicycle inspection station, child safety ID cards were handed out, Charleston County Consolidated Dispatch provided education on Smart9-1-1 and Text9-1-1 and the Charleston County Sheriff's Office helicopter was on display. Area businesses donated food and beverages.

August 11 – FTO Louise Hardy met with the students at Chesterbrook Academy in Mount Pleasant for the schools end of summer public education event. FTO Hardy explained the job of a police officer and allowed the children to inspect her patrol car.
